Cong An Ha Noi FC (VIE) has committed an offence under Article 56 of the AFC Disciplinary and Ethics Code, read together with Article 25 of the AFC Champions League Two 2025/26 Competition Regulations. 2. Cong An Ha Noi FC (VIE) has committed an offence under Article 67.1 of the AFC Disciplinary and Ethics Code, read together with Article 25 of the AFC Champions League Two 2025/26 Competition Regulations. 3. The AFC Champions League Two 2025/26 (Knock-out Stage) match between Cong An Ha Noi FC (VIE) and Tampines Rovers FC (SGP) which took place on 11 February 2026 is forfeited by Cong An Ha Noi FC (VIE). Accordingly, applying Article 25.1 of the AFC Disciplinary and Ethics Code, Cong An Ha Noi FC (VIE) shall be considered to have lost the AFC Champions League Two 2025/26 (Knock-out Stage) match between Cong An Ha Noi FC (VIE) and Tampines Rovers FC (SGP) which took place on 11 February 2026 by a score of 0-3. 4. Cong An Ha Noi FC (VIE) is ordered to pay a fine of USD2,000/-, in accordance with Article 56 of the AFC Disciplinary and Ethics Code, which shall be settled within 30 days from the date that this decision is communicated in accordance with Article 11.3 of the AFC Disciplinary and Ethics Code. 5. Fifty per cent of the USD80,000/- participation fee due to Cong An Ha Noi FC (VIE) under Article 51.7 of the AFC Champions League Two 2025/26 Competition Regulations (i.e. USD40,000/-) shall not be paid to Cong An Ha Noi FC (VIE). To the extent that any such monies have already been paid, it shall be repaid to the AFC by Cong An Ha Noi FC (VIE) within thirty (30) days from the date that this decision is communicated. 6. For the avoidance of doubt, in accordance with Article 14.6 of the AFC Disciplinary and Ethics Code, Mr. Rogerio Alves Dos Santos (AFC/174273/BRA) and Mr. Stefan Ingo Mauk (AFC/79558/AUS) are deemed to have served the one match automatic suspension in the match between Cong An Ha Noi FC (VIE) and Tampines Rovers FC (SGP) which took place on 11 February 2026.	1.
