One (1) match suspension shall be served in the AFC Futsal Asian Cup 2026 (Qualifiers) match China PR vs. Hong Kong, China on 24 September 2025. 3. The remaining one (1) match suspension shall be carried over in accordance with Article 38.2.1 of the AFC Disciplinary and Ethics Code. 4. Mr. Gu Haitao (AFC/73946/CHN) is ordered to pay a fine of USD1,000/- in accordance with Article 48.2 of the Code. 5. Mr. Setha Sachakboth (AFC/138136/CAM) is suspended for one (1) match, which includes the one (1) match automatic suspension arising from his expulsion in the match Cambodia vs. Tajikistan on 22 September 2025. 2. The one (1) match suspension shall be served in the AFC Futsal Asian Cup 2026 (Qualifiers) match between Macau vs. Cambodia on 24 September 2025. 3. Mr. Setha Sachakboth (AFC/138136/CAM) is ordered to pay a fine of USD1,000/- in accordance with Article 48.2 of the AFC Disciplinary and Ethics Code. 4.
