Mr. Shen Siming (AFC/99788/CHN) is suspended for one (1) match, which includes the one (1) match automatic suspension arising from his expulsion in the match China P.R. vs. Thailand on 7 October 2023.</p> <p>2. The one (1) match suspension shall be served in accordance with Article 38.2.4 of the AFC Disciplinary and Ethics Code.</p> <p>3. Mr. Shen Siming (AFC/99788/CHN) is ordered to pay a fine of USD1,000/- in accordance with Article 48.2 of the AFC Disciplinary and Ethics Code.</p> <p>4. The fine shall be settled within 30 days from the date that this decision is communicated in accordance with Article 11.3 of the AFC Disciplinary and Ethics Code.</p> <p>5.
