Al Ain FC (UAE) is ordered to pay a fine of USD25,000/- which shall be settled within thirty (30) days from the date that this Decision is communicated in accordance with Article 11.3 of the AFC Disciplinary and Ethics Code.</p> <p>4. Al Ain FC (UAE) is ordered to play one (1) match with a partial stadium closure (i.e. 25% stadium closure).
