1	AFC Champions League 2022 (Knock-out Stage), Al Hilal SFC (KSA) vs. Urawa Red Diamonds (JPN) on 29 April 2023	Al Hilal SFC (KSA)	Official Countdown (Article 3.2, AFC Competition Operations Manual)	1) The Defendant's representative(s) delayed coming out of their team dressing room and caused a delay to the commencement of the first period of the Match by two (2) minutes. 2) The Defendant's representative(s) delayed coming out of their team dressing room and caused a delay to the commencement of the second period of the Match by one (1) minute. (This is the fourth violation of the Defendant in the recidivism period).	1. Al Hilal SFC (KSA) is ordered to pay a fine of USD4,375/- for violating Article 3.2 of the AFC Competition Operations Manual. 2. In accordance with Articles 34.1 and 34.3 of the AFC Disciplinary and Ethics Code, USD1,095/- of the amount referred to in Paragraph 1 of this decision is suspended for a probationary period of 2 years. Should another violation of a similar nature occur within the probationary period, the suspension is automatically revoked, and the sanction applied; it is added to the sanction pronounced for the new infringement. 3. The unsuspended portion of the fine referred to in Paragraph 1 of this decision (i.e. USD3,280/-) shall be settled within 90 days from the date that this decision is communicated in accordance with Article 11.3 of the AFC Disciplinary and Ethics Code. 4. 2	AFC Champions League 2022 (Knock-out Stage), Al Hilal SFC (KSA) vs. Urawa Red Diamonds (JPN) on 29 April 2023	Al Hilal SFC (KSA) player, Mr. Salem Mohammed S Aldawsari (AFC/63458/KSA)	Serious infringements punishable by an expulsion (Article 47, AFC Disciplinary and Ethics Code)	The Defendant was expelled by the Referee for striking an opponent player in the stomach with his studs, an act of violent conduct.	1. Mr. Salem Mohammed S Aldawsari (AFC/63458/KSA) is suspended for three (3) matches, which includes the one (1) match automatic suspension arising from his expulsion in the match Al Hilal SFC (KSA) vs. Urawa Red Diamonds (JPN) on 29 April 2023. 2. One (1) match suspension was served in the AFC Champions League 2022 (Knock-Out Stage) match Urawa Red Diamonds (JPN) vs. Al Hilal SFC (KSA) on 6 May 2023. 3. The remaining two (2) match suspensions shall be carried over in accordance with Article 38.2.3 of the AFC Disciplinary and Ethics Code. 4. Mr. Salem Mohammed S Aldawsari (AFC/63458/KSA) is ordered to pay a fine of USD1,000/- in accordance with Article 48.2 of the AFC Disciplinary and Ethics Code. 5. In accordance with Articles 34.1 and 34.3 of the AFC Disciplinary and Ethics Code, USD750/- of the amount referred to in Paragraph 4 of this decision is suspended for a probationary period of two (2) years. Should another violation of a similar nature occur within the probationary period, the suspension is automatically revoked, and the sanction applied; it is added to the sanction pronounced for the new infringement. 6. The unsuspended portion of the fine referred to in Paragraph 4 of this decision (i.e. USD250/-) shall be settled within 90 days from the date that this decision is communicated in accordance with Article 11.3 of the AFC Disciplinary and Ethics Code. 7. 3	AFC U17 Women's Asian Cup 2024 (Round 1), Myanmar vs. India on 28 April 2023	Myanmar player, Ms. Yu Ya Naing (AFC/156781/MYA)	Serious infringements punishable by an expulsion (Article 47, AFC Disciplinary and Ethics Code) Bringing the game into disrepute (Article 50, AFC Disciplinary and Ethics Code)	The Defendant was expelled by the Referee for pushing and swinging a punch at an opponent player, an act of violent conduct. The Defendant kicked a water bottle while walking outside the pitch after receiving a red card, an act of unsporting behaviour bringing the game into disrepute.	1. Ms. Yu Ya Naing (AFC/156781/MYA) is suspended for three (3) matches, which includes the one (1) match automatic suspension arising from her expulsion in the match Myanmar vs. India on 28 April 2023. 2. The three (3) matches suspension shall be served in accordance with Article 38.2.2 of the AFC Disciplinary and Ethics Code. 3. Ms. Yu Ya Naing (AFC/156781/MYA) is ordered to pay a fine of USD350/- in accordance with Articles 39.4 and 11.2.1 read together with Article 48.2 of the AFC Disciplinary and Ethics Code. 4. Ms. Yu Ya Naing (AFC/156781/MYA) is ordered to pay a fine of USD250/- for violating Article 50.1 of the AFC Disciplinary and Ethics Code. 5. The total fine of USD600/- shall be settled within 30 days from the date that this decision is communicated in accordance with Article 11.3 of the AFC Disciplinary and Ethics Code. 6.
