DEFINITIONS

In these Competition Regulations, capitalised terms shall have the following meanings, unless the context specifically indicates otherwise:

AWCL	The AFC Women's Champions League.
AFC Women's Club Competitions Ranking	A ranking of the Member Associations in relation to the results of all their clubs in the AWCL determined in accordance with Appendix 1 of these Regulations.
AFC Women's Football Committee	The Standing Committee of the AFC described in Article 47 of the AFC Statutes.
Away Club	A Participating Club playing a Match in the Competition away from its home Stadium.
Champion	The Participating Club that wins the final Match of the Competition.
Competition	The AFC Women's Champions League 2026/27, which includes, without limitation, all Matches, all activities on the Field of Play (other than Matches), opening ceremonies, presentation or closing ceremonies, press conferences or Official Functions connected therewith.
Finals	The centralised final stage of AWCL comprising a total of three (3) Matches (i.e. two (2) semi finals and one (1) final Match of the Competition).
Financial Contribution	The payment(s) to be made to a Participating Club in accordance with Article 54.
Group Stage	The second stage of the Competition held in accordance with these Regulations.
Host Association	A Member Association approved by the AFC to organise, host and stage Matches in the Competition.
Host Club	A Participating Club which is approved by the AFC to organise, host and stage Matches in the Competition in collaboration with the respective Host Association.
International Competition	An international football competition organised by the AFC in conjunction with other continental football confederations and/or by FIFA in conjunction with other continental football confederations.
Knockout Stage	The third stage of the Competition comprising the quarter-finals and Finals held in accordance with these Regulations.
League	A professional league and/or amateur league which consists of a combination of Clubs within the territory of a Football Association and which is subordinate to and under the authority of that Football Association.
Manual	The AFC Competition Operations Manual which sets out the operational responsibilities of the relevant stakeholders in relation to the organising, hosting and staging of Matches and Competitions.

Participating Club	A Club which is approved by the AFC to participate in the Competition.
Preliminary Stage	The first stage of the Competition held in accordance with these Regulations.
Regulations	These Competition Regulations.
Titelholder	The champion of the most recently concluded edition of an AFC Women's Champions League.

For the purposes of these Regulations, and provided the context so permits:

- (a) the singular shall include the plural and vice-versa;
- (b) the masculine gender shall include the feminine and vice-versa;
- (c) references to natural persons shall include any legal person or corporation;
- (d) references to the AFC shall include its successors and permitted assigns, and where the context requires, the AFC Committees;
- (e) references to the Commercial Rights Partner or Commercial Affiliates shall include, where advised by the AFC, their successors and permitted assigns;
- (f) all defined terms, unless otherwise stated herein, shall bear the same meaning as ascribed in the AFC Statutes and the Manual, unless the context indicates otherwise; and
- (g) references to Articles shall mean the Articles of these Regulations, unless expressly stated otherwise.

SECTION 1: GENERAL PROVISIONS

1. AFC WOMEN'S CHAMPIONS LEAGUE 2026/27

- 1.1. The AFC stages the AWCL annually for Participating Clubs.
- 1.2. These Regulations govern the rights, duties, and responsibilities of the AFC, the Participating Clubs (as well as their Member Associations and Leagues), Host Associations, Participating Players and Participating Officials taking part in the Competition.
- 1.3. These Regulations and all related directives, decisions, guidelines, and circulars issued by the AFC shall be binding upon all parties participating and involved in the preparation, organisation, and hosting of Matches in the Competition. Further details in relation to various aspects of the Competition may be communicated to the Participating Clubs (through their affiliated Member Associations) via circular letters. In the event of any discrepancy between the circular letters and these Regulations, the circular letters shall prevail to the extent of the inconsistency.
- 1.4. The Manual forms an integral part of and shall be read in conjunction with these Regulations. The Manual shall be binding upon all parties participating and involved in the preparation, organisation, and hosting of Matches in the Competition. In the event of any discrepancy between these Regulations and the Manual, these Regulations shall prevail to the extent of the inconsistency.
- 1.5. Any failure to adhere to any matter set out in these Regulations, the Manual, and/or any related directives, decisions, guidelines, and/or circulars issued by the AFC may be referred to the AFC Disciplinary and Ethics Committee.
- 1.6. Any rights and Proprietary Interests associated with the Competition that are not granted by these Regulations and/or specific agreements to any Member Association and/or any Participating Club shall vest in the AFC.
- 1.7. Any reference to the AFC Statutes and to the AFC and FIFA regulations shall refer to those valid at the time of application.

2. THE ASIAN FOOTBALL CONFEDERATION

- 2.1. The AFC Women's Football Committee shall be responsible for overseeing the organisation of the Competition in accordance with the AFC Statutes. The AFC General Secretariat shall carry out the necessary administrative work in support of the AFC Women's Football Committee.
- 2.2. The responsibilities of the AFC General Secretariat shall include, but are not limited to:
 - 2.2.1. supervising general preparations and deciding on the Competition format, the draws, and the entries to the Competition;

- 2.2.2. determining the Match Schedule (cf. Article 12);
 - 2.2.3. selecting Stadiums for the Competition after consultation with the Host Clubs and/or Host Associations (cf. Article 15);
 - 2.2.4. appointing Match Officials and any other AFC Delegation for each Match;
 - 2.2.5. choosing and/or approving the official football and stipulated technical material;
 - 2.2.6. approving the choice of the World Anti-Doping Agency (WADA) accredited laboratories that will carry out doping analyses (cf. Article 49);
 - 2.2.7. reporting cases where appropriate to the AFC Disciplinary and Ethics Committee (cf. Article 59);
 - 2.2.8. providing insurance coverage for the AFC Delegation appointed to any Match from the time of their departure from their home Member Association to their departure from the Venue (cf. Article 51); and
 - 2.2.9. dealing with any other aspect of the Competition that is not the responsibility of any other body pursuant to these Regulations or the AFC Statutes (cf. Article 70).
- 2.3. All decisions made by the AFC Women's Football Committee and/or AFC General Secretariat in relation to the Competition are final and binding and not appealable.
- 2.4. All decisions made by the AFC Disciplinary and Ethics Committee in relation to the Competition are subject to the AFC Disciplinary and Ethics Code.

3. PARTICIPATING CLUBS AND MEMBER ASSOCIATIONS

- 3.1. The principal obligations and responsibilities of each nominated Participating Club and its Member Association are stipulated in the Participating Team Agreement (PTA), these Regulations, the Manual, the AFC Statutes, and all other AFC regulations, directives, guidelines and circulars.
- 3.1.1. Each Participating Club that has qualified for the Competition must submit a PTA.
 - 3.1.2. The PTA and other such documents as requested by the AFC General Secretariat in relation to the PTA shall be completed and submitted to the AFC General Secretariat via AFCAS in accordance with the deadline provided by the AFC General Secretariat.
 - 3.1.3. Failure to submit a validly completed PTA to the AFC General Secretariat by the deadline shall result in the non-participation of the relevant Participating Club.
- 3.2. Each Participating Club shall ensure, as a condition of its participation in the Competition, that every member of its Official Team Delegation for each Match is aware of and agrees to comply with the PTA.

- 3.3. Each Participating Club shall undertake to:
- 3.3.1. observe all obligations set out in the PTA, these Regulations, the Manual, the AFC Statutes, and all other AFC regulations, directives, guidelines and circulars, and applicable national and supra-national laws;
 - 3.3.2. comply with the latest Laws of the Game;
 - 3.3.3. accept that all the administrative, disciplinary and refereeing matters connected with the Competition shall be settled by the AFC in compliance with these Regulations;
 - 3.3.4. field its strongest team throughout the Competition;
 - 3.3.5. observe the principles of fair play;
 - 3.3.6. ensure the good conduct of its Official Team Delegation and of any person carrying out duties on its behalf throughout the Competition, which includes but is not limited to their arrival on the territory of the Host Association until their departure;
 - 3.3.7. as Host Club, make the appropriate arrangements for the staging of Matches in conjunction with its Member Association and the AFC General Secretariat in accordance with these Regulations and any instructions from the AFC;
 - 3.3.8. accept all arrangements made by the Host Club or Host Association (as appropriate) in agreement with the AFC;
 - 3.3.9. ensure that its Participating Players and Participating Officials attend and participate in all official activities and events, including, without limitation, any draw ceremonies, Club workshops, team arrival meeting, match coordination meeting, press conference, and other media and marketing activities in accordance with the instructions issued by the AFC;
 - 3.3.9.1. failure to attend and/or fully participate in any official activity or event shall result in the Participating Club being fined at least USD2,500; and
 - 3.3.9.2. the AFC Disciplinary and Ethics Committee may issue further sanctions at its discretion.
 - 3.3.10. provide to the AFC, free of charge, prior to the Competition, any photographs, audio/visual materials and/or information regarding the Participating Club, Participating Players and/or Participating Officials, including without limitation, statistics and historical information and any further information as requested by the AFC;
 - 3.3.11. link the official URL for the Competition on its official website; and
 - 3.3.12. not establish any digital, media or social media platform in connection with the Competition without the involvement and express written approval of the AFC

General Secretariat.

- 3.4. Each Participating Club and its Member Association shall, at their own expense, be solely responsible throughout the Competition for:
 - 3.4.1. the procurement of insurance coverage for:
 - 3.4.1.1. its Official Team Delegation which shall include without limitation hospital and surgical insurance, travel insurance, and sports equipment insurance for all Matches; and
 - 3.4.1.2. all risks in connection with staging and organising Matches, including but not limited to public liability insurance. The AFC shall be expressly identified as a named insured party in all such insurance policies;
 - 3.4.2. all other necessary insurance policies, which must provide an appropriate guaranteed sum for injury and damage to persons, objects, and property, and correspond with the specific circumstances of the Participating Club. Such policies must cover all risks connected with the organising, hosting, and staging of Matches in the Competition, exempt the AFC from all claims and liabilities, and name the AFC as a co-insured. The AFC must be notified of all insurance policies and may request copies of any and all policies at its discretion;
 - 3.4.3. payment of incidental expenses and for any costs incurred by its Official Team Delegation (cf. Article 51);
 - 3.4.4. payment of any costs of extending the stay of any member of its Official Team Delegation in any Host Association (cf. Article 51);
 - 3.4.5. obtaining visas to enter the territory of a Host Association. This includes all costs related to the visa application process;
 - 3.4.6. payment of all taxes, fees, duties and any other costs related to the importation and/or exportation of equipment, merchandise and/or goods to be used for the Competition; and
 - 3.4.7. guaranteeing the safety and security at its Stadium (cf. Articles 15 and 46).
- 3.5. Each Participating Club and/or its Member Association shall indemnify, defend, and hold the AFC and all of its officers, directors, employees, representatives, agents, subsidiaries, local organising committees and all other auxiliary persons free and harmless against any and all liabilities, obligations, losses, damages, penalties, claims, actions, fines, and expenses (including reasonable legal expenses) of whatsoever kind or nature resulting from, arising out of, or attributable to, any non-compliance with these Regulations by the Participating Club and/or its Member Association, its Official Team Delegation, its affiliates and any third parties contracted to the Participating Club and/or its Member Association.

- 3.6. The Member Association of the Host Club is responsible for nominating a local general coordinator, a local media officer and a local safety and security officer for each Match that is played within its territory and shall submit the nomination to the AFC General Secretariat for approval (together with the Venue information) in accordance with the deadline(s) notified by the AFC General Secretariat. Should a Match be played at a Neutral Venue in another Member Association, the Member Association of the Host Club shall still be held accountable for the relevant nomination, and this must be done in collaboration with the Host Association.
- 3.7. Each Participating Club shall arrive at the Venue for a Match or Matches of a centralised group at least two (2) days before the first Match and depart from the Venue no later than one (1) day after the last Match.
- 3.7.1. Should an Away Club wish to arrive at the Venue only one (1) day before the relevant Match, it shall submit a request via an official letter to the AFC General Secretariat with valid reasons and arrival flight itinerary details at least seven (7) days prior to the Match for approval (to be accepted at its sole discretion).
- 3.7.2. Should the AFC General Secretariat accept such a request, the late arrival of the relevant Club shall not interrupt the timing of Official Functions and/or the participation of the relevant Participating Club in Official Functions.
- 3.7.3. The requirements and timings set out in Article 3.7 shall also apply to any Host Club which is hosting a home Match at a Neutral Venue.
- 3.7.4. Participating Clubs shall not play in any non-official matches when travelling to and from the Venue of an away Match.
- 3.8. It is acknowledged that one or more Participating Clubs may qualify directly for one or more International Competitions as a result of their performance in the Competition. Where applicable, each such Participating Club undertakes to participate in the relevant International Competition(s).
- 3.9. Participating Clubs are not authorised to represent the AFC or the Competition without the prior written approval of the AFC General Secretariat.
- 3.10. All Participating Players and Participating Officials are encouraged to attend the AFC Annual Awards if they are nominated for an award.
- 3.11. Each Participating Club and its Member Association shall ensure that any decision made by the AFC relating to its duties and responsibilities is enforced immediately.
- Preliminary Stage, Group Stage and Finals
- 3.12. The principal obligations and responsibilities of the Host Associations will be stipulated in the relevant circular to be issued by the AFC General Secretariat prior to the relevant stage of the Competition, as well as in these Regulations, the Manual, the AFC Statutes and all other applicable AFC regulations, directives, guidelines and circulars.

4. ENTRY

- 4.1. Eligible Member Associations may nominate up to one (1) Participating Club from its Member Association to participate in the Competition. To be eligible to participate in the Competition, Member Associations shall:
 - 4.1.1. be ranked in the FIFA Women's World Ranking;
 - 4.1.2. have domestic competition(s) (either in a league or knockout format) consisting of a minimum of ten (10) matches per club from all the domestic competition(s);
 - 4.1.3. have a full-time dedicated official who oversees operational matters for the domestic competition; and
 - 4.1.4. have a documented plan for implementation of women's football club licensing requirements to at least the domestic top division league/competition by the start of the 2027/28 season at the latest.
- 4.2. Each Member Association shall set the methodology for nomination of its representative club(s) for the Competition. Each Member Association shall ensure that, without exception:
 - 4.2.1. its club(s) qualify for the Competition based on sporting merit;
 - 4.2.2. it clearly identifies a domestic competition for the purposes of entries to the Competition;
 - 4.2.3. the club nominated by the Member Association must be the winner of its domestic competition ending in the domestic sporting season immediately preceding the Competition. In case the domestic competition consists of different formats (e.g. a knockout stage after the completion of a league stage), the Member Association shall be responsible for determining the winner of the domestic top division league as part of its nomination principles;
 - 4.2.4. the principles of objectivity, transparency, integrity and non-discrimination are respected with a view to ensuring fair entry into the Competition; and
 - 4.2.5. the nomination principles are approved by the relevant competent bodies within its Member Association and/or League prior to submission to the AFC.
- 4.3. The Participating Clubs shall be seeded in accordance with the AFC Women's Club Competitions Ranking 2024/25 (published at the end of the 2024/25 season). The number of Participating Clubs in the Preliminary Stage and slot allocation to the Group Stage shall be determined depending on the number of Participating Clubs as follows:

Titleholder Slot

- 4.4. The Titleholder shall be allocated a direct slot as follows:
- 4.4.1. where the Titleholder qualifies for a direct slot in accordance with Articles 4.2 and 4.3, the Titleholder shall occupy an existing direct slot allocated to its Member Association.
 - 4.4.2. where the Titleholder qualifies for an indirect slot in accordance with Articles 4.2 and 4.3, such indirect slot shall be converted into a direct slot, which shall then be allocated to the Titleholder.
 - 4.4.3. where the Titleholder does not qualify for any direct or indirect slot in accordance with Articles 4.2 and 4.3, one (1) additional direct slot shall be allocated to the Titleholder.
- 4.5. Unless decided otherwise by the AFC, where the Titleholder participates in the Competition, it shall, for operational purposes (e.g. seeding for entries, draws), be deemed to be the highest-seeded Participating Club within the Group Stage of the Competition.
- 4.6. Notwithstanding Article 4.4, the Titleholder must meet the requirements set out in Article 3.1 and 4.1 in order for the relevant slot to be allocated to it.
- 4.7. Eligible Clubs must complete a PTA and submit it to the AFC General Secretariat in accordance with Article 3 to confirm their entry into the Competition.
- 4.7.1. Subject to Article 4.7.2, the name and logo of a Participating Club shall not refer to the popular name and/or logo of any third party entity, regardless of whether that third party entity is a commercial partner or sponsor of the Participating Club.
 - 4.7.2. The AFC General Secretariat may grant an exception to the restriction(s) in Article 4.7.1 in the following circumstances:
 - 4.7.2.1. the name/logo of any Participating Club that refers to any third party entity is a pre-existing name/logo which has been utilised on a long-term basis by the Participating Club and either the third party entity was directly involved in the creation of the Participating Club (by financial or other means) or the third party entity holds a majority of the shareholders' voting rights in the Participating Club; and/or
 - 4.7.2.2. the Participating Club has previously competed in an AFC competition utilising the name/logo.

The burden of proof shall rest on the relevant Participating Club to prove its compliance with the provision(s) of Article 4.7.2 and the AFC General Secretariat shall be entitled, at its discretion, to request information from the relevant Participating Club in this regard. The AFC General Secretariat shall decide on any exceptions at its sole discretion, and any such decisions shall be final and binding and not appealable.

- 4.8. Participating Clubs are not permitted to change their name for the Competition after the first Match in the Competition has been played.

5. RANKING

- 5.1. The principles for determining the AFC Women's Club Competitions Ranking are set out in Appendix 1 of these Regulations. The calculations for the AFC Women's Club Competitions Ranking carried out by the AFC General Secretariat are final and binding and not appealable.
- 5.2. The AFC General Secretariat shall publish the AFC Women's Club Competitions Ranking after each Season.

6. WITHDRAWAL FROM THE COMPETITION

- 6.1. All Participating Clubs undertake that they shall play all their Matches in the Competition until elimination.
- 6.2. Without limitation, any Participating Club that (for any reason):
 - 6.2.1. informs the AFC General Secretariat in writing that it does not intend to or is unable to report to a Venue and/or for a Match;
 - 6.2.2. fails to report to a Venue and/or for a Match;
 - 6.2.3. refuses or fails to continue a Match;
 - 6.2.4. leaves the Stadium prior to the completion of a Match;
 - 6.2.5. is excluded, suspended or banned by any competent body from participating in the Competition (or any stage of the Competition) at any time after the draw of the Competition (or stage, as appropriate); or
 - 6.2.6. is excluded, suspended or banned by any competent body from participating in any Match in the Competition at any time after the relevant Match has been scheduled,shall be considered to have withdrawn from the Competition.
- 6.3. Subject to Articles 6.5 to 6.7, the AFC Women's Football Committee shall be responsible for making the necessary decisions where a Participating Club withdraws from the Competition, whether before or after commencement of the Competition (as applicable), and shall be entitled to take any action it considers appropriate in such circumstances, including without limitation regarding whether or not to change the technical regulations (cf. Section 4) and/or the competition system (cf. Article 7) and, where applicable, the means of effecting such change(s).
- 6.4. The AFC Women's Football Committee shall be responsible for determining events of Force Majeure in connection with any withdrawal and shall, subject to Articles 6.5 to 6.7, be entitled

to take any action it considers appropriate in such circumstances. Any Participating Club that wishes to put forward a case of Force Majeure for the consideration of the AFC Women's Football Committee must do so in writing (with supporting evidence) no later than thirty (30) days after the date of its withdrawal. The AFC General Secretariat may put forward cases of Force Majeure for the consideration of the AFC Women's Football Committee at its discretion at any time (provided that the case has not been referred to the AFC Disciplinary and Ethics Committee).

- 6.5. In the event that a Participating Club withdraws from the Competition, whether before or after commencement of the Competition (as applicable), the Competition shall continue with the remaining Participating Clubs and Matches without any replacement.

For the avoidance of doubt, this Article 6.5 shall apply in all instances and is applicable even in cases of Force Majeure determined by the AFC Women's Football Committee.

Notwithstanding the foregoing, the AFC General Secretariat may, at its discretion, put forward a request to replace the relevant Participating Club and, where applicable, the means of effecting such replacement, for the consideration of the AFC Women's Football Committee, in which case the AFC Women's Football Committee shall be entitled to take a decision on the matter.

- 6.6. Any Participating Club that withdraws from the Competition after it has commenced shall have all its Matches cancelled and considered null and void. No yellow cards, red cards, points and goals in those Matches shall be taken into consideration when determining the final rankings in a group pursuant to Articles 7.2 and 7.3.

For the avoidance of doubt, this Article 6.6 shall apply in all instances and is applicable even in cases of Force Majeure determined by the AFC Women's Football Committee.

- 6.7. Where any Participating Club fails to comply with Article 6.1 and withdraws from the Competition at any stage, the case shall be referred to the AFC Disciplinary and Ethics Committee.

In this regard, any Participating Club that withdraws from the Competition:

- 6.7.1. before it has commenced, shall be fined:

6.7.1.1. at least USD10,000 if its withdrawal occurred thirty (30) days or more before its first Match in the Competition; or

6.7.1.2. at least USD20,000 if its withdrawal occurred less than thirty (30) days before its first Match in the Competition.

- 6.7.2. after it has commenced, shall be fined:

6.7.2.1. at least USD25,000 if its withdrawal occurred after the commencement of the Preliminary Stage; or

- 6.7.2.2. at least USD50,000 if its withdrawal occurred after the commencement of the Group Stage; or
- 6.7.2.3. at least USD100,000 if its withdrawal occurred after the commencement of the Knockout Stage.
- 6.7.3. may be disqualified from participating in one (1) or more future seasons of the AFC Women's Champions League; and
- 6.7.4. where relevant, may be disqualified from participating in any tournament organised under Article 3.8, if qualification has been attained.

In addition, in all instances, the AFC Disciplinary and Ethics Committee shall order the relevant Participating Club to return to the AFC any Financial Contribution that has been paid in support of its participation in the Competition (or, if not yet paid, to forfeit its right to that Financial Contribution) and to pay compensation for any and all damages or losses suffered by, where applicable, the other Participating Clubs, the AFC, the Commercial Rights Partner, Commercial Affiliates and the Host Association(s). The amount of compensation shall be determined by the AFC Disciplinary and Ethics Committee.

This Article 6.7 is not applicable in cases of Force Majeure determined by the AFC Women's Football Committee, but shall apply in all other instances.

- 6.8. All decisions of the AFC Women's Football Committee under Articles 6.3 to 6.5 shall be final and binding and not appealable.

SECTION 2 : COMPETITION SYSTEM AND MATCH SCHEDULE

7. COMPETITION SYSTEM

- 7.1. The Competition shall consist of three (3) stages:
 - 7.1.1. the Preliminary Stage;
 - 7.1.2. the Group Stage; and
 - 7.1.3. the Knockout Stage.
- 7.2. Should the competition system involve groups of several Participating Clubs, the ranking in each group shall be determined in accordance with the Manual and in descending order as follows:
 - 7.2.1. higher number of points obtained in all group Matches;
 - 7.2.2. if two (2) or more Participating Clubs are equal on points, the following criteria are applied to determine the ranking (in descending order):
 - Head-to-Head criteria
 - 7.2.2.1. higher number of points obtained in the group Matches played among the Participating Clubs in question;
 - 7.2.2.2. superior goal difference from the group Matches played among the Participating Clubs in question;
 - 7.2.2.3. higher number of goals scored in the group Matches played among the Participating Clubs in question;
 - Tiebreaker
 - 7.2.2.4. if, after having applied the Head-to-Head criteria and two (2) or more Participating Clubs still have an equal ranking, the Head-to-Head criteria shall be reapplied exclusively to the Matches between the Participating Clubs in question to determine their final rankings. If this procedure does not lead to a decision, the Group Results criteria shall apply;
 - Group Results criteria
 - 7.2.2.5. superior goal difference from all group Matches;
 - 7.2.2.6. higher number of goals scored from all group Matches;
 - 7.2.2.7. Penalties only if two (2) Participating Clubs still have an equal ranking and have played their last group Match against each other;

- 7.2.2.8. the lower score calculated according to the number of yellow and red cards received in the group Matches (in accordance with the Manual); or
 - 7.2.2.9. the drawing of lots.
- 7.3. Should the competition system require the best-ranked Participating Clubs from among different groups to advance, the rankings shall be determined by the method set out in the Manual.
 - 7.4. Depending on the number of entries, or in the case of withdrawal or suspension of any Participating Clubs, the AFC Women's Football Committee may change the competition system and/or technical regulations. Such decisions are final and binding and not appealable.

8. PRELIMINARY STAGE

- 8.1. The Preliminary Stage shall consist of Participating Clubs drawn into groups, with each group played in a centralised league format. The number of Participating Clubs and groups shall be determined in accordance with Article 4.3 and the following principles:
 - 8.1.1. All Participating Clubs shall be seeded in accordance with the AFC Women's Club Competitions Ranking 2024/25 (published at the end of the 2024/25 season).
 - 8.1.2. Participating Clubs with a higher seed shall be given priority in the event that any bye(s) are available due to the number of Participating Clubs, unless otherwise determined by the AFC General Secretariat at its sole discretion.
- 8.2. Participating Clubs shall play one (1) Match against each Participating Club within their respective group in accordance with the Match Schedule.
- 8.3. At the conclusion of the Preliminary Stage:
 - 8.3.1. the first-placed Participating Club in each group shall qualify for the Group Stage; and
 - 8.3.2. all other Participating Clubs shall be eliminated from the Competition.

9. GROUP STAGE

- 9.1. The Group Stage shall consist of twelve (12) Participating Clubs drawn into three (3) groups of four (4) each, with each group played in a centralised league format. Participating Clubs from the same Member Association shall not be drawn into the same group.
- 9.2. Participating Clubs shall play one (1) Match against each Participating Club within their respective group in accordance with the Match Schedule.
- 9.3. At the conclusion of the Group Stage:

- 9.3.1. the first-placed and second-placed Participating Clubs in each group, as well as the two (2) best third-placed Participating Clubs among all groups shall qualify for the Knockout Stage; and
- 9.3.2. all other Participating Clubs shall be eliminated from the Competition.

10. KNOCKOUT STAGE

- 10.1. The Knockout Stage shall consist of the quarter-finals (played in a single-leg knockout format) and the Finals (played in a centralised knockout format).
- 10.2. The eight (8) Participating Clubs that qualify from the Group Stage shall play in the quarter-finals and the pairings of these Matches shall be determined by a draw as follows:
 - 10.2.1. The first-placed Participating Clubs of each group and the best second-placed Participating Club among all groups shall be paired against one (1) of the remaining Participating Clubs and host each Match.
 - 10.2.2. Participating Clubs from the same group in the Group Stage shall not be paired against each other.
- 10.3. The four (4) winners of the quarter-finals shall play in the semi-finals as follows:

SF1: Winner QF1 vs Winner QF2
SF2: Winner QF3 vs Winner QF4

For the avoidance of doubt, the list above does not necessarily represent the chronological order in which the Matches will be played.

- 10.4. The two (2) winners of the semi-finals shall play in the final Match of the Competition as follows:
Final Match: Winner SF1 vs Winner SF2

11. EXTRA TIME AND PENALTIES

- 11.1. If no winner is determined at the end of normal playing time in any Match in the Knockout Stage, Extra Time comprising two (2) periods of fifteen (15) minutes each shall be played.
- 11.2. Extra Time shall be played after an interval of five (5) minutes at the end of normal playing time. A short drink break (which should not exceed one (1) minute) is permitted at the interval of half time in Extra Time.
- 11.3. If no winner is determined at the end of Extra Time, Penalties shall be taken in accordance with the Laws of the Game and the Manual.

12. MATCH SCHEDULE

- 12.1. All Matches shall be played in accordance with the AFC competitions calendar. The dates are final and binding and not appealable.
- 12.2. The Match Schedule for the Preliminary Stage shall be determined following the confirmation of the Participating Clubs and the official draw (if applicable). The date and format of the official draw for the Preliminary Stage shall be determined by the AFC General Secretariat. The Host Clubs shall propose the kick-off times in writing to the AFC General Secretariat for approval by the deadline set by the AFC General Secretariat. The AFC General Secretariat reserves the right to change the proposed kick-off times in consultation with the Participating Clubs.
- 12.3. The Match Schedule and kick-off times for the Group Stage and Knockout Stage shall be determined following the official draw for the relevant stages of the Competition. The date and format of the official draws shall be determined by the AFC General Secretariat.
 - 12.3.1. Following the relevant draws, the AFC General Secretariat shall determine the Match Schedule taking into consideration sporting, organisational (including safety and security), marketing and broadcasting matters.
- 12.4. The AFC General Secretariat shall have the sole discretion to amend the Match Schedule at any time and for any reason.

13. CANCELLATION OF MATCHES

- 13.1. For any Match that is cancelled as a result of Force Majeure, the AFC Women's Football Committee shall decide on the matter at its sole discretion and take whatever action deemed necessary.
 - 13.1.1. Decisions made pursuant to Article 13.1 are final and binding and not appealable.
- 13.2. Any Match that is cancelled, except in cases of Force Majeure recognised by the AFC Women's Football Committee, may lead to the imposition of sanctions by the AFC Disciplinary and Ethics Committee against the relevant party that caused the cancellation in accordance with the AFC Disciplinary and Ethics Code.
- 13.3. If a Match cannot commence for any reason, the procedure described in the Manual shall be followed.

14. ABANDONMENT OF MATCHES

- 14.1. For any Match that is abandoned as a result of Force Majeure, the AFC Women's Football Committee shall decide on the matter at its sole discretion and take whatever action is deemed necessary.
 - 14.1.1. Decisions made pursuant to Article 14.1 are final and binding and not appealable.
- 14.2. Any Match that is abandoned, except in cases of Force Majeure recognised by the AFC Women's Football Committee, may lead to the imposition of sanctions by the AFC Disciplinary and Ethics

Committee against the relevant party that caused the abandonment in accordance with the AFC Disciplinary and Ethics Code.

- 14.3. If a Match is stopped by the referee for any reason, the procedure described in the Manual shall be followed.

SECTION 3: STADIUMS AND OFFICIAL TRAINING SITES

15. STADIUMS

Quarter-finals

- 15.1. The Participating Clubs shall ensure that all of their home Matches are played in Stadiums which meet the requirements defined in the AFC Stadium Regulations, the Manual and all other applicable AFC regulations. The AFC General Secretariat may carry out inspections at any time before and during the Competition to check whether the requirements are met. All costs related to any such inspection shall be borne by the relevant Participating Club.
 - 15.1.1. Each Participating Club shall, by no later than the deadline set by the AFC General Secretariat, nominate the Stadium to be utilised for all its home Matches when entering the Competition. The Stadium nominated shall be the normal home stadium of the Participating Club for matches in its League. In case the normal home stadium of the Participating Club does not meet the requirements set out in Article 15.1, the Participating Club may exceptionally nominate a Neutral Venue located within the territory of its Member Association or another Member Association.
- 15.2. Unless an exception is granted by the AFC General Secretariat at its sole discretion, each Participating Club must play all its home Matches in the one and only Stadium approved by the AFC General Secretariat throughout the Competition. Any request for an exception shall be submitted to the AFC General Secretariat in writing at least thirty (30) days prior to the relevant Match.
- 15.3. The AFC General Secretariat may reject the nomination of any Stadium and take any decisions pursuant to this Article 15.3 at its sole discretion. If the AFC General Secretariat deems, for whatever reason, that a Stadium is unable to stage any Match(es), the relevant Participating Club shall propose an alternate Stadium. Should the Participating Club not propose an acceptable alternate Stadium by the deadline set by the AFC General Secretariat, the AFC General Secretariat may select a Neutral Venue to stage the Match(es), including the home Stadium of the opponent Participating Club.
 - 15.3.1. In all cases, the Participating Club concerned shall remain responsible as the Host Club for all arrangements for the staging of its home Match(es), including but not limited to all costs as set out in these Regulations.
 - 15.3.2. Should the Participating Club refuse to participate in the Match(es) at the Neutral Venue selected by the AFC General Secretariat, it shall be considered to have withdrawn from the Competition and be subject to Article 6.
- 15.4. For any Match played at a Neutral Venue, the Host Club must organise and stage the Match in accordance with these Regulations, the Manual and any instructions from the AFC, in cooperation with the Host Association and the local authorities.
- 15.5. Host Clubs shall ensure that no football matches and/or other events or activities are held at

any Stadium during the period starting at least two (2) days prior to the Match until one (1) day after the Match, unless prior written permission has been obtained from the AFC General Secretariat. The Stadium shall be delivered to the AFC for its exclusive use during this period.

15.5.1. A Host Club that fails to comply with Article 15.5 shall be fined at least USD5,000.

15.5.2. The AFC Disciplinary and Ethics Committee may impose further sanctions at its discretion.

Preliminary Stage, Group Stage and Finals

15.6. The Host Club or Host Association (as appropriate) shall ensure that all Matches of the Competition are played in Stadiums which meet the requirements defined in the AFC Stadium Regulations, the Manual and any other applicable AFC regulations. The AFC General Secretariat may carry out stadium inspections at any time before and during the Competition to check whether the requirements are met. All costs related to any such inspection shall be borne by the Host Club or Host Association (as appropriate).

15.7. The relevant Host Club or Host Association (as appropriate) shall ensure that no football matches and/or any other events or activities are held in any Stadium during the period starting at least seven (7) days prior to the first Match of the respective stage until one (1) day after the last Match in the Stadium in the respective stage of the Competition unless prior written permission has been obtained from the AFC General Secretariat.

15.8. Unless otherwise specified or directed by the AFC General Secretariat, the Stadiums shall be made available to the AFC for its exclusive use for the duration of the period starting at least seven (7) days prior to the first Match of the respective stage until one (1) day after the last Match in the Stadium in the respective stage of the Competition.

15.9. A Host Club or Host Association (as appropriate) that fails to comply with Articles 15.7 and 15.8 shall be:

15.9.1. fined at least USD10,000; and

15.9.2. the AFC Disciplinary and Ethics Committee may impose further sanctions at its discretion.

16. FIELD OF PLAY

16.1. If a Host Club considers the Field of Play unfit for a Match, it shall immediately inform the AFC, the Away Club and the Match Officials before their departure to the Venue.

16.1.1. A Participating Club that fails to comply with Article 16.1 shall be liable for all costs incurred for the travel, board and lodging expenses of the parties involved.

16.2. The AFC Match commissioner and Match Officials will inspect each Stadium prior to the Match and ensure that all arrangements are in accordance with the Laws of the Game. If the arrangements and the conditions of the Field of Play, including the dimensions of the goal

and field are not in accordance with the Laws of the Game, the AFC Match commissioner shall issue instructions to the Host Club to ensure rectification.

16.2.1. If, in the opinion of the referee, the instructions issued pursuant to Article 16.2 are not complied with by the start of the Match, the Host Club shall forfeit the Match in accordance with the AFC Disciplinary and Ethics Code.

17. OFFICIAL TRAINING SITES

Quarter-finals

17.1. Each Participating Club shall nominate the Official Training Sites to be utilised for its home Matches when entering the Competition. The AFC General Secretariat makes the final decision to approve any Official Training Site and may carry out inspections at any time before and during the Competition to check whether the requirements are met. All costs related to the inspection shall be borne by the relevant Participating Club.

17.1.1. The AFC General Secretariat reserves the right to refuse the nomination of an Official Training Site and require a Participating Club to nominate an alternate Official Training Site.

17.1.2. Official Training Sites shall be situated no more than thirty (30) minutes or thirty (30) kilometres away from the Accommodation of the Away Club, unless otherwise approved by the AFC.

17.2. Official Training Sites shall contain a fully equipped training field prepared to match condition.

17.2.1. A Host Club that fails to comply with Article 17.2 shall be fined at least USD5,000.

17.2.2. The AFC Disciplinary and Ethics Committee may impose further sanctions at its discretion.

17.3. Official Training Sites shall be made available at least two (2) days prior to each Match until the commencement of the Match. They shall not be used for any other purpose during this period unless written permission has been obtained from the AFC General Secretariat.

17.3.1. A Host Club that fails to comply with Article 17.3 shall be fined at least USD5,000.

17.3.2. The AFC Disciplinary and Ethics Committee may impose further sanctions at its discretion.

17.4. Participating Clubs must strictly follow the official training schedule decided by the AFC at its sole discretion. Should both Participating Clubs wish to train at the same time, the Away Club shall be given priority.

Preliminary Stage, Group Stage and Finals

17.5. The Host Association shall ensure that Official Training Sites are available at least seven (7) days prior to the first Match of the respective stage in the Venue until one (1) day after the last Match

of the respective stage in the Venue. They shall not be used for any other purpose during this period, unless written permission has been obtained from the AFC General Secretariat.

17.5.1. A Host Association that fails to comply with Article 17.5 shall be fined at least USD10,000.

17.5.2. The AFC Disciplinary and Ethics Committee may impose further sanctions in addition to Article 17.5.1.

17.6. Participating Clubs must solely utilise Official Training Sites for training (excluding any official training that may be held at a Stadium) from four (4) days prior to their first Match or from their arrival, whichever is latest.

SECTION 4: TECHNICAL REGULATIONS

18. LAWS OF THE GAME

- 18.1. All Matches shall be played in accordance with the Laws of the Game. In the case of any discrepancy in the interpretation of the Laws of the Game, the English version shall prevail.
- 18.2. Each Match shall last ninety (90) minutes, comprising two (2) periods of forty-five (45) minutes, with a half-time interval of fifteen (15) minutes and wherever required in accordance with Article 11, Extra Time shall be played.
- 18.3. Five (5) of the substitutes listed on the match start list may take part in the Match utilising a maximum of three (3) substitution opportunities in accordance with Law 3 of the Laws of the Game. Any Participating Player who has been substituted may take no further part in that Match.
- 18.4. One (1) additional substitute and one (1) additional substitution opportunity may be used when a Match goes into Extra Time (regardless of whether the Participating Club has already utilised the full number of permitted substitutes and opportunities).
- 18.5. In accordance with Law 3 of the Laws of the Game, a maximum of one (1) additional permanent concussion substitution may be used by each Participating Club in a Match. A concussion substitution may be made regardless of the number of substitutes and opportunities already used. The opposing Participating Club then has the option to use an additional substitute for any reason.
- 18.6. The AFC may, at its discretion, decide to use football technologies in any Match(es) in the Competition or in the Competition as a whole (including goal-line technology (GLT), a video assistant referee (VAR) system, electronic performance and tracking systems (EPTS) or any other football technology) in accordance with the Laws of the Game.

19. REFEREEING

- 19.1. If the referee is prevented from carrying out his/her duties, such referee shall be replaced by the fourth official. The same applies to either of the assistant referees if a reserve assistant referee is not appointed.
- 19.2. A video assistant referee (VAR) may assist the referee to make a decision using replay footage in accordance with the relevant provisions of the Laws of the Game in force at the time of the Competition.

20. TEAM BENCH AND TECHNICAL AREA

- 20.1. A maximum of twelve (12) Participating Players and a maximum of eleven (11) Participating Officials are permitted to sit on the team bench during a Match, provided they are in possession of the appropriate Accreditation Devices.

- 20.2. The Host Club or Host Association (as appropriate) shall reserve a minimum of twenty-one (21) Team Technical Seats for each Participating Club's additional Participating Players and Participating Officials who will not be seated on the team bench.
- 20.3. Only Participating Players or Participating Officials who are registered in accordance with Article 23.3 are permitted to sit on the Team Technical Seats, provided they are in possession of the appropriate Accreditation Devices.

21. FOOTBALLS

Preliminary Stage

- 21.1. The footballs used in the Preliminary Stage shall be selected and supplied by each Host Club/ Host Association. The Host Club/Host Association shall supply each Away Club with twenty (20) of the same footballs for its training throughout the period of its stay.
- 21.2. Participating Clubs shall solely utilise the training footballs provided by the Host Club/Host Association for official training and warming-up purposes.
- 21.3. Only footballs that bear one (1) of the FIFA quality marks shall be utilised for the Preliminary Stage.

Group Stage and Knockout Stage

- 21.4. The footballs used in the Group Stage and Knockout Stage shall be selected and supplied by the AFC General Secretariat.
- 21.5. Each Participating Club entering the Group Stage shall receive twenty (20) footballs for training prior to the Group Stage. Participating Clubs shall solely utilise the twenty (20) training footballs provided by the AFC for training and warming-up purposes during the Matches.
- 21.6. The Host Club and/or Host Association (as appropriate) shall receive footballs for each Match it hosts, and these Match balls must only be used for the Match(es).
- 21.7. Each Member Association and/or its Participating Club(s) is responsible for any taxes and/or fees pertaining to the customs clearance of footballs delivered to the Member Association and when travelling for their away Matches.

22. EQUIPMENT

- 22.1. The AFC General Secretariat has the sole authority to approve the equipment (including kit) in accordance with the AFC Equipment Regulations.
- 22.2. Each Participating Club shall indemnify the AFC and hold the AFC harmless from any and all damages in the event that a conflict arises as a result of any endorsement deal existing between itself and its sponsor(s) which contravenes the AFC Equipment Regulations.

SECTION 5 : OFFICIAL TEAM DELEGATION

23. OFFICIAL TEAM DELEGATION

- 23.1. All Participating Players and Participating Officials of an Official Team Delegation will be issued with Accreditation Devices (as applicable) authorised by the AFC General Secretariat. Each Participating Club shall produce the Accreditation Cards for its Participating Players and Participating Officials using the materials provided by the AFC General Secretariat.
- 23.2. Each Participating Club shall ensure that no person in its Official Team Delegation or otherwise affiliated to it, enters or is present on its team bus, in its team dressing room, on the Field of Play, or in any other Controlled Access Area without being in physical possession of the necessary Accreditation Devices, which has been validly issued to such person.
- 23.3. Subject to the conditions set out below, for each Match in the Competition, Participating Clubs shall register an Official Team Delegation comprising a minimum of eighteen (18) and a maximum of twenty-three (23) Participating Players and a minimum of four (4) and a maximum of eleven (11) Participating Officials.
 - 23.3.1. Each Participating Club may nominate an additional nine (9) Participating Officials as part of its Official Team Delegation, who shall receive the same Accreditation Cards as the eleven (11) Participating Officials referred to above.
 - 23.3.2. All costs related to the additional nine (9) Participating Officials shall be borne by the relevant Participating Club.
- 23.4. No individual shall be simultaneously registered as both a Participating Player and a Participating Official at any stage of the Competition.

24. REGISTRATION OF PLAYERS

- 24.1. There are three (3) registration windows for the Competition. During each registration window, each Participating Club shall submit a list of a minimum of eighteen (18) and a maximum of thirty-five (35) Participating Players.
- 24.2. Each Participating Club must register a minimum of three (3) goalkeepers in its registration.
- 24.3. Participating Players must be assigned a number between 1 and 99. Number 1 shall be reserved for a goalkeeper if the number is used. Each Participating Player shall wear the same number allocated in her first registration during all Matches in the Competition. Participating Players additionally registered in accordance with Articles 25.2 to 25.4 may only be allocated a new number.
- 24.4. If a Participating Club fails to submit its list of Participating Players in accordance with these Regulations by the stipulated deadline, it shall be considered to have withdrawn from the Competition and be subject to Article 6. Proof of submission by email and/or any other

communication channel will not be accepted.

- 24.5. Should the AFC General Secretariat not receive all required documents for each registration window, the individual concerned shall be considered not eligible to be registered and participate in the relevant stage of the Competition.

25. REGISTRATION WINDOWS

- 25.1. Each Participating Club shall submit via AFCAS its registration of Participating Players and supporting documents in accordance with deadlines set for the registration windows stipulated in this Article 25. In principle, the applicability of each registration window is as follows:

Registration Window 1

- 25.2. This registration window applies only to all Participating Clubs in the Preliminary Stage. It shall close fifteen (15) days prior to the first Match of the respective group in the Preliminary Stage. Once the registration of Participating Players has been received by the AFC General Secretariat and after the stipulated deadline has passed, each Participating Club may:

- 25.2.1. no later than five (5) days prior to their first Match in the Competition, replace or add up to eight (8) Participating Players for any reason provided that the maximum number of registered players is not exceeded.

Registration Window 2

- 25.3. This registration window applies to all Participating Clubs in the Group Stage. It shall close thirty (30) days prior to the first Match of the respective group in the Group Stage. Once the registration of Participating Players has been received by the AFC General Secretariat and after the stipulated deadline has passed, each Participating Club may:

- 25.3.1. no later than five (5) days prior to their first Match in the Group Stage, replace or add up to eight (8) Participating Players for any reason provided that the maximum number of registered players is not exceeded.

Registration Window 3:

- 25.4. This registration window applies to all Participating Clubs in the Knockout Stage. It shall close fifteen (15) days prior to the first Match in the Knockout Stage. Once the registration of Participating Players has been received by the AFC General Secretariat and after the stipulated deadline has passed, each Participating Club may:

- 25.4.1. no later than five (5) days prior to their first Match in the Knockout Stage, replace or add up to five (5) Participating Players for any reason provided that the maximum number of registered players is not exceeded; and

- 25.4.2. no later than five (5) days prior to their first Match in the Finals, replace or add up to three (3) Participating Players for any reason provided that the maximum number of registered players is not exceeded and the newly registered Participating Player(s) have only been registered with the Participating Club (as per Article 26.1.2) after the

deadline stipulated in Article 25.4.1 (i.e. five (5) days prior to the relevant Participating Club's first Match in the Knockout Stage).

- 25.5. For the avoidance of doubt, no further replacement or addition of Participating Players shall be permitted after the deadline stipulated in Article 25.4.2.
- 25.6. Participating Players registered pursuant to the additional registration provisions contained in Articles 25.2.1, 25.3.1, 25.4.1 and 25.4.2 shall be considered to have been registered during the same registration window covered by those relevant provisions.
- 25.7. Notwithstanding the foregoing provision for additional registration (cf. Articles 25.2.1, 25.3.1, 25.4.1 and 25.4.2), if at any stage during the Competition, two (2) or more Participating Players who are registered as goalkeepers suffer long-term injuries or illness, the relevant Participating Club may request to replace one (1) or more of these goalkeeper(s) by registering one (1) or more new Participating Players as goalkeepers (as appropriate).
 - 25.7.1. An injury or illness shall be considered long-term for the purposes of this Article 25.7.1 if it will or can reasonably be expected to last for thirty (30) days or longer (as from the date of the request).
 - 25.7.2. A medical report, in English, must be submitted to the AFC General Secretariat detailing the extent of the injury or illness to the relevant Participating Player(s) before any replacement(s) can be approved by the AFC General Secretariat.
 - 25.7.3. Any replacement must be requested no later than twenty-four (24) hours before the kick-off time of the Participating Club's next Match.
 - 25.7.4. The AFC General Secretariat shall decide on any replacement(s) at its sole discretion, and any such decisions shall be final and binding and not appealable.
 - 25.7.5. Incidents involving the provision of false or misleading evidence or information to the AFC in connection with any replacement under this Article (as regards the provision of medical reports or otherwise) may be referred to the AFC Disciplinary and Ethics Committee.
 - 25.7.6. For the avoidance of doubt, once a Participating Player has been replaced, such player cannot be re-registered in the Competition (including as a replacement) during the same registration window.
- 25.8. Participating Players registered pursuant to the provisions for additional registration set out in this Article 25 shall only be eligible to participate in the Competition after receiving their Accreditation Cards.

26. ELIGIBILITY OF PLAYERS

- 26.1. Each Participating Club shall ensure that all players:

- 26.1.1. are duly registered with the AFC pursuant to these Regulations; and
- 26.1.2. are duly registered with the Participating Club in accordance with its Member Association's transfer rules and registration periods, as well as the FIFA Regulations on the Status and Transfer of Players.
- 26.2. Individuals who meet the criteria set out in Article 26.1 are eligible to participate in the Competition, subject to the provisions of the AFC Disciplinary and Ethics Code.
- 26.3. The approval of the registration of a Participating Player by the AFC General Secretariat does not mean that the Participating Player is eligible to participate in the Competition. Each Participating Club is responsible for fielding only eligible Participating Players in a Match. Failure to do so shall lead to the consequences stipulated in the AFC Disciplinary and Ethics Code.
- 26.4. A Participating Player shall be deemed ineligible, without limitation, if:
 - 26.4.1. there is a violation of Article 26.1; or
 - 26.4.2. she participates in a Match contrary to a decision of the AFC Disciplinary and Ethics Committee, these Regulations, or the operation of the AFC Disciplinary and Ethics Code; or
 - 26.4.3. the AFC determines that any document submitted during registration is falsified or forged or otherwise invalid.

27. DOCUMENTS FOR REGISTRATION OF PLAYERS

- 27.1. Participating Players must be registered via AFCAS with the supporting documents set out in the Manual, together with any additional information and/or documents requested by the AFC General Secretariat.
- 27.2. Each Participating Club shall ensure to submit valid and authentic documents for the registration of its Participating Players.

28. PLAYER STATUS

- 28.1. Subject to Article 24.1, there shall be no limit on the number of foreign Participating Players that each Participating Club may register during each registration window, however, each Participating Club may only select up to six (6) foreign Participating Players in the player selection list. In case more than five (5) foreign Participating Players are selected in the player selection list, then at least one (1) of these foreign Participating Players must hold the nationality of a Member Association.
- 28.2. A stateless Participating Player registered by a Participating Club shall be treated as a foreign Participating Player not holding the nationality of a Member Association unless it can be proven (to the AFC's satisfaction, at its sole discretion) that:

- 28.2.1. such Participating Player has validly participated in a match for a representative team of the Member Association to which the relevant Participating Club is affiliated (the "Local MA") in an official competition of any category or any type of football, in which case she shall be treated as a local Participating Player; or
 - 28.2.2. such Participating Player has validly participated in a match for a representative team of another Member Association which is not the local MA in an official competition of any category or any type of football, in which case she shall be treated as a Participating Player holding the nationality of a Member Association.
- 28.3. Any Participating Player who has acquired a new nationality of a Member Association (e.g. through naturalisation) and wishes to participate in the Competition utilising that nationality must demonstrate, at least, one of the following:
- 28.3.1. that the nationality was acquired more than five (5) years before the date of the Participating Player's registration for the Competition; or
 - 28.3.2. that she is eligible to participate for the representative team of the relevant Member Association in accordance with the FIFA Regulations Governing the Application of the Statutes.
 - 28.3.3. Any Participating Player who does not meet the relevant requirements stipulated above shall not be eligible to take part in the Competition utilising that nationality.
- 28.4. Any Participating Player who is eligible to represent more than one (1) Football Association on account of her nationality of one (1) country (e.g. a player with a Chinese nationality may be eligible to represent three (3) different Member Associations) and wishes to participate in the Competition utilising the nationality of a Member Association must demonstrate one (1) of the following:
- 28.4.1. that she has participated in an official competition for a representative team of the relevant Member Association; or
 - 28.4.2. that she is eligible to participate for a representative team of the relevant Member Association in accordance with the FIFA Regulations Governing the Application of the Statutes.
 - 28.4.3. Any Participating Player who does not meet the relevant requirements stipulated above shall not be eligible to take part in the Competition utilising that nationality.
- 28.5. A Participating Player can only change her registered nationality during the registration windows (cf. Article 25), including the additional registration period as per Articles 25.2.1, 25.3.1, 25.4.1 and 25.4.2 stipulated in these Regulations, subject to the following:
- 28.5.1. a Participating Player is only permitted to change her nationality once during the Competition; and

- 28.5.2. the Participating Player must provide a clear copy of her passport of the country the player wishes to represent.
- 28.6. A Participating Player shall only be registered to one (1) Participating Club per registration window.
- 28.7. A Participating Player shall not be eligible to play a Match for more than one (1) Participating Club per stage of the Competition (cf. Article 7.1). A Participating Player that has been fielded by a Participating Club in a stage of the Competition cannot be registered for another Participating Club in that same stage. For the avoidance of doubt, a substitute player who has not been fielded by a Participating Club shall be entitled to play for another Participating Club in the same stage of a Competition, provided that she is registered in accordance with these Regulations.
- 28.8. If a violation of Article 28.6 or Article 28.7 occurs:
- 28.8.1. the Participating Player may be sanctioned with a ban on participating in a minimum of one (1) future season of the AFC Women's Champions League, unless she can demonstrate that extenuating circumstances existed;
- 28.8.2. the Participating Club shall forfeit any Match in which the Participating Player has been fielded in accordance with the AFC Disciplinary and Ethics Code; and
- 28.8.3. the AFC Disciplinary and Ethics Committee may impose further sanctions at its discretion.
- 28.9. For the purposes of the employment contract of a Participating Player, her date of registration with a Participating Club shall be:
- 28.9.1. for Participating Players who transferred internationally to the Participating Club: the date of confirmation of receipt of the International Transfer Certificate ("ITC") or the date of provisional registration with the Participating Club's Member Association pursuant to the FIFA Regulations on the Status and Transfer of Players, submitted in accordance with Article 27; and
- 28.9.2. for Participating Players who transferred domestically to the Participating Club or are "homegrown" players: the official date of the contract submitted in accordance with Article 27.

29. PLAYER SELECTION LIST

- 29.1. Each Participating Club must submit a player selection list prior to each Match which identifies the starting eleven (11), including the team captain and up to twelve (12) substitutes comprising individuals registered in the relevant registration window.
- 29.1.1. Each Participating Player who is selected on the player selection list must be promptly available at the player and equipment check undertaken by the AFC Match

commissioner on Match day.

- 29.2. Each Participating Club must hand its player selection list signed by the head coach or the team manager to the AFC Match commissioner at least ninety (90) minutes prior to the commencement of each Match.

30. REGISTRATION OF OFFICIALS

- 30.1. Each Participating Club may nominate a minimum of four (4) and a maximum of eleven (11) Participating Officials. Each Participating Club may also nominate an additional nine (9) Participating Officials in accordance with Article 23.3.
- 30.2. Each Participating Club shall submit the supporting documents in accordance with Article 31 via AFCAS by the deadlines set for the relevant registration window stipulated in Article 25.
- 30.3. The registration list of Participating Officials must fulfil the following requirements:
- 30.3.1. at least one (1) person on the coaching staff shall be female (e.g. head coach, assistant coach, fitness coach, goalkeeping coach, etc.); and
 - 30.3.2. at least one (1) person on the medical staff shall be female (e.g. team doctor or physiotherapist).
- 30.4. The Participating Clubs are also encouraged to have at least one (1) female member on their key administrative staff (e.g. team manager, team media officer, etc.).
- 30.5. Each Participating Club must include the following four (4) Participating Officials in the registration list:
- 30.5.1. Head coach;
 - 30.5.2. Team manager;
 - 30.5.3. Team media officer; and
 - 30.5.4. an appropriately qualified person responsible for medical matters (e.g. team doctor or physiotherapist).
- 30.6. Up to eleven (11) Participating Officials may sit on the team bench for each Match. The following three (3) Participating Officials must be registered on the officials on the substitution bench list and must sit on the team bench for each Match:
- 30.6.1. Head coach;
 - 30.6.2. Team manager; and
 - 30.6.3. an appropriately qualified person responsible for medical matters (e.g. team doctor

or physiotherapist).

- 30.7. Each Participating Club may register video analysts, however for each Match, only one (1) of them shall be entitled to receive the necessary Accreditation Devices and they shall be the only member of an Official Team Delegation entitled to record Matches. They shall use only one (1) lightweight amateur camera. This recording shall be strictly for technical purposes and should not interfere with Match operations or be utilised by any Broadcast Partner or otherwise be distributed. For the avoidance of doubt, video analysts are only allowed to film Match(es) involving their Participating Club, unless otherwise agreed in writing by the two (2) Participating Clubs of the relevant Match. A fixed camera position will be determined by the AFC at each Stadium for the use by video analysts, subject to the availability of space.
- 30.8. Should the AFC General Secretariat not receive all required documents by the stipulated deadline for a registration window, the individual concerned shall be considered not eligible to be registered and participate in the relevant stage of the Competition.
- 30.9. Once the registration of Participating Officials has been received by the AFC General Secretariat and after the stipulated deadline has passed, Participating Clubs may replace or add Participating Officials at any reason at any stage with twenty-four (24) hours' notice to the AFC General Secretariat by submitting the documents set out in Article 31 via AFCAS, provided that:
 - 30.9.1. the maximum number of registered officials is not exceeded;
 - 30.9.2. to replace the Participating Officials, a Participating Club must provide their Accreditation Cards to the AFC and shall receive the Accreditation Cards of the replacement Participating Officials in exchange; and
 - 30.9.3. the replacement Participating Officials shall only be eligible to participate in the Competition after receiving their Accreditation Cards.
- 30.10. Each Participating Club shall submit the officials on the substitution bench list ninety (90) minutes prior to the commencement of each Match, at the latest.

31. DOCUMENTS FOR REGISTRATION OF OFFICIALS

- 31.1. Participating Officials must be registered via AFCAS with the supporting documents set out in the Manual, together with any additional information and/or documents requested by the AFC General Secretariat.
- 31.2. Each Participating Club shall ensure to submit authentic documents for registration of its Participating Officials.

SECTION 6 : MEDIA

32. MEDIA ACCESS

- 32.1. Each Host Club or Host Association (as appropriate) shall ensure that the AFC, Commercial Rights Partners, Commercial Affiliates, the Host Broadcaster, and all Broadcast Partners have free access to the Stadium from two (2) days prior to the first Match in the Stadium until one (1) day after the last Match in the Stadium in the respective stage of the Competition to allow for the resolution of any technical issues and for the assembly and/or disassembly of the relevant infrastructure required to execute the Media Rights.

33. TEAM DRESSING ROOM FILMING

- 33.1. If requested by the AFC, each Participating Club shall complete its respective Match day team dressing room set-up no later than two and a half (2.5) hours prior to Match kick-off and thereafter shall grant access to the AFC, the Host Broadcaster and all Broadcast Partners to its team dressing room to conduct the following activities:
 - 33.1.1. to film the Match day set-up of the team dressing room;
 - 33.1.2. to allow the Broadcast Partner's reporter to conduct and film stand-up reporting (as approved by the AFC); and
 - 33.1.3. to film the arrival and entry of Participating Players and Participating Officials.
- 33.2. All team dressing room footage will be pre-recorded and edited before any transmission. The duration allowed in each team dressing room shall be confirmed by the AFC and/or local media officer in consultation with the respective Participating Club.
- 33.3. Participating Clubs shall ensure that no technical, tactical or confidential materials are visible in the team dressing room during filming.
- 33.4. Any Participating Club that fails to complete the team dressing room set-up for filming, when requested by the AFC, shall be fined at least USD2,500. The AFC Disciplinary and Ethics Committee may impose further sanctions at its discretion.

34. PRESS CONFERENCES

- 34.1. The Host Club or Host Association (as appropriate) is responsible for the organisation of a pre-Match press conference to be conducted under the supervision of the AFC and/or local media officer at least one (1) day prior to the first Match it hosts in the respective stage of Competition.
- 34.2. The head coach and a minimum of one (1) of the key Participating Players (as determined by the AFC at its sole discretion) of each Participating Club must attend pre-Match press

conferences organised in accordance with Article 34.1. The AFC General Secretariat shall, in collaboration with each Host Club or Host Association, decide the final timing of the pre-Match press conference.

- 34.3. The head coach of each Participating Club must attend a post-Match press conference for each Match in which they participate, commencing no later than fifteen (15) minutes after the Match. Subject to compliance with the AFC Anti-Doping Regulations, where additional awards (e.g. Player of the Match, etc.) are granted, the winner of such awards must also attend the post-Match press conference.
- 34.4. Each Participating Club is responsible for the interpretation and translation of any communication made by its Participating Players and Participating Officials into English. Interpretation into the local language (if applicable) shall be the responsibility of the Host Club or Host Association (as appropriate).
- 34.5. Any individual who fails to attend an obligatory press conference shall be fined at least USD2,500. The relevant Participating Club shall also be held liable for any failure to attend a press conference in accordance with Article 3.3.9. The AFC Disciplinary and Ethics Committee may impose further sanctions at its discretion.

35. INTERVIEWS

- 35.1. If requested by the AFC, Participating Clubs shall make their head coach and one (1) selected Participating Player available for an interview of up to ten (10) minutes, to be recorded by the Host Broadcaster or any other Broadcast Partner, Commercial Affiliate and/or the AFC. All interview locations shall be designated by the AFC and/or local media officer.
 - 35.1.1. For the Group Stage, any such interview shall be conducted one (1) day prior to the Match.
 - 35.1.2. For the Knockout Stage, any such interview shall be conducted one (1) or two (2) days prior to the Match.
- 35.2. If requested by the AFC, Participating Clubs shall make a key Participating Player (as determined by the AFC at its sole discretion) available on Match day for an interview of not more than ninety (90) seconds at their point of arrival at the Stadium for the Match.
- 35.3. If requested by the AFC, Participating Clubs shall make their head coach available on Match day for an interview of not more than ninety (90) seconds at their point of arrival at the Stadium for the Match.
- 35.4. Any individual who fails to conduct an interview when requested shall be fined at least USD2,500. The relevant Participating Club may also be held liable for any failure to conduct an interview when requested in accordance with Article 3.3.9. The AFC Disciplinary and Ethics Committee may impose further sanctions at its discretion.

36. FLASH INTERVIEWS

- 36.1. Participating Players and Participating Officials are not permitted to give interviews at the Stadium without the express permission of the AFC.
- 36.2. The AFC and/or local media officer may designate an area for multilateral and unilateral flash interviews to be conducted by the Host Broadcaster and the Broadcast Partners (as applicable) following the conclusion of each Match.
- 36.3. If requested by the AFC, a maximum of five (5) Participating Players and the head coach from each Participating Club shall participate in flash interviews carried out by the Host Broadcaster and other Broadcast Partners following the conclusion of each Match.
- 36.4. Any individual who fails to conduct the flash interview(s) when requested shall be fined at least USD2,500. The relevant Participating Club may also be held liable for any failure to conduct a flash interview when requested in accordance with Article 3.3.9. The AFC Disciplinary and Ethics Committee may impose further sanctions at its discretion.

37. MIXED ZONE

- 37.1. The head coach and all Participating Players of each Participating Club shall pass through the mixed zone on their way from their team dressing room to their bus after each Match.
- 37.2. Any individual who fails to pass through the mixed zone shall be fined at least USD2,500. The relevant Participating Club may also be held liable for any failure to pass through the mixed zone in accordance with Article 3.3.9. The AFC Disciplinary and Ethics Committee may impose further sanctions at its discretion.

38. ACCESS TO MATCH FOOTAGE

Preliminary Stage

- 38.1. The relevant Host Club or Host Association (as appropriate) shall provide the AFC with the Match footage in an acceptable broadcast quality and format within forty-eight (48) hours of the conclusion of the relevant Match.

Group Stage & Knockout Stage

- 38.2. The AFC shall provide each Participating Club with access to download the relevant Match footage of each Match in accordance with the applicable AFC guidelines.

SECTION 7 : TICKETING

39. GENERAL REQUIREMENTS

- 39.1. Tickets, electronic or hard copy, shall include seat numbering and serial numbering, and only include AFC Marks, Competition Marks, and/or of Commercial Affiliates approved by the AFC General Secretariat.
- 39.2. The AFC General Secretariat reserves the right at its sole discretion to substitute the seating area or the gate entrance identified on a Ticket with another, if deemed appropriate.
- 39.3. The Host Club and its Member Association or Host Association (as appropriate) must ensure that access to the Stadium is granted to the AFC Delegation, Away Club Official Team Delegation, Commercial Rights Partner, Commercial Affiliates, Media and travelling supporters without any discrimination.
- 39.4. The AFC General Secretariat shall determine the Ticketing policy for the Finals.

40. TERMS AND CONDITIONS

- 40.1. Unless otherwise advised by the AFC General Secretariat in writing, each Host Club or Host Association (as appropriate) shall be responsible at its own cost for the production, distribution, and sales of all Tickets. Such matters are subject to the approval of the AFC General Secretariat. The AFC General Secretariat shall provide a Ticket template design to the Host Club or Host Association (as appropriate).
- 40.2. The AFC General Secretariat may, in collaboration with each Host Club or Host Association (as appropriate), issue special Ticketing terms and conditions which are applicable to all Ticket holders.
- 40.3. The AFC General Secretariat may change the terms and conditions and shall advise the Host Club or Host Association (as appropriate) on any requirements relating to Ticket production, distribution and/or sales.

41. COMPLIMENTARY TICKETS

- 41.1. Each Host Club or Host Association (as appropriate) shall provide Complimentary Tickets to the AFC and/or AFC Commercial Rights Partner for each Match in the quantities and categories as instructed by the AFC General Secretariat, in accordance with the following deadlines:
 - 41.1.1. Preliminary Stage: latest by seven (7) days before the Match;
 - 41.1.2. Group Stage: latest by seven (7) days before the Match;
 - 41.1.3. Quarter-finals: latest by seven (7) days before the Match; and

- 41.1.4. Finals: latest by seven (7) days before the first Match of the semi-finals.
- 41.2. All Complimentary Tickets shall be provided in a continuous block.
- 41.3. In certain circumstances (including, without limitation, where the relevant Away Club has not been determined by the deadline set out in Article 41.1), a Host Club or Host Association (as appropriate) may provide Complimentary Tickets to the AFC, AFC Commercial Rights Partner and/or Commercial Affiliates which contain generic information (e.g. "Winner of Preliminary Stage 2").

Quarter-finals

- 41.4. Each Host Club shall provide the following Complimentary Tickets to the Away Club no later than at the match coordination meeting (which shall take place no later than one (1) day prior to the Match):
- 41.4.1. two (2) VVIP Tickets;
- 41.4.2. five (5) VIP Tickets; and
- 41.4.3. twenty (20) Tickets of the next-best category (as determined by the AFC General Secretariat).
- 41.5. Notwithstanding Article 41.4, the AFC General Secretariat reserves the right to request any additional complimentary Tickets for a Match, the number of which shall be communicated to the Host Club at the appropriate time.

Preliminary Stage, Group Stage and Finals

- 41.6. The AFC reserves all Ticketing rights relating to the Finals.
- 41.7. The Host Club or Host Association (as appropriate) shall provide the following Complimentary Tickets to each Participating Club in the respective stage of the Competition:
- 41.7.1. two (2) VVIP Tickets for each Match the Participating Club participates in;
- 41.7.2. five (5) VIP Tickets for each Match the Participating Club participates in;
- 41.7.3. twenty (20) Tickets for the next-best category (as determined by the AFC General Secretariat) for each Match the Participating Club participates in; and
- 41.7.4. two (2) Tickets of the next-best category (as determined by the AFC General Secretariat) for all other Matches at the Venue not involving the relevant Participating Club.
- 41.8. Notwithstanding Article 41.7, the AFC General Secretariat is entitled to request any additional complimentary Tickets for a Match, the number of which shall be communicated to the Host Club or Host Association (as appropriate) at the appropriate time.

42. PURCHASABLE TICKETS

- 42.1. Each Host Club or Host Association (as appropriate) must make available at least five per cent (5%) of the net saleable capacity of each Stadium available exclusively to the supporters of the Away Club in a segregated and safe area to be determined by the AFC General Secretariat and the Host Club or Host Association (as appropriate).
- 42.2. The number of Tickets to be purchased must be declared to the Host Club no later than seven (7) days prior to the Match with full payment by the Away Club to the Host Club. The Away Club is responsible for all Tickets purchased, even if the Tickets are not utilised. The price of the Tickets shall not exceed the price of comparable Tickets that are sold to the supporters of the Host Club.
- 42.3. Each Host Club or Host Association (as appropriate) shall provide the AFC Commercial Rights Partner with the opportunity to buy Tickets at face value for each Match as instructed by the AFC General Secretariat. The number of Tickets to be purchased must be declared at a time to be mutually agreed between the AFC Commercial Rights Partner and the Host Club.
- 42.4. The AFC General Secretariat shall be able to purchase Tickets at face value and on an individual Match basis from each Host Club for itself and its Commercial Affiliates.
- 42.5. The AFC is entitled to request any additional purchasable Tickets for a Match, the number of which shall be communicated to the Host Club or Host Association (as appropriate) at the appropriate time.

Finals

- 42.6. The Host Club or Host Association (as appropriate) must make available for each Match at least eight per cent (8%) of the net saleable capacity of each Stadium available exclusively to the supporters of each Participating Club playing in a Match, in a segregated and safe area to be determined by the AFC General Secretariat and the Host Club or Association (as appropriate).
- 42.7. The number of Tickets to be purchased must be declared by each Participating Club in accordance with the Ticketing timeline and guidelines issued by the AFC General Secretariat. Each Participating Club is responsible for all Tickets purchased, even if the Tickets are not utilised. The price of the Tickets shall not exceed the price of comparable Tickets that are sold to the general public by the relevant Host Club or Host Association (as appropriate).
- 42.8. The Host Club or Host Association (as appropriate) shall provide the AFC Commercial Rights Partner with the opportunity to buy Tickets at face value for each Match. The number of Tickets to be purchased must be declared at a time to be mutually agreed between the AFC Commercial Rights Partner and the Host Club or Host Association (as appropriate).
- 42.9. The AFC is entitled to request any additional purchasable Tickets for a Match, the number of which shall be communicated to the Host Club or Host Association (as appropriate) at the appropriate time.

SECTION 8: COMMERCIAL

43. COMMERCIAL RIGHTS

- 43.1. The AFC is the owner of all Commercial Rights emanating from the Competition as well as from any other related events under its jurisdiction, without any restrictions as to content, time, place and law. The AFC General Secretariat may grant the Host Clubs the Commercial Rights to the Preliminary Stage, in whole or in part, in accordance with the Manual which governs the rights, duties, and responsibilities of all parties regarding the Commercial Rights. All other Commercial Rights not granted under these Regulations shall be retained by the AFC for use and exploitation.
- 43.2. Each Host Club and its Member Association or Host Association (as appropriate) shall use its best efforts/endeavours in seeking political and administrative support from all local, regional and national governmental authorities to ensure the effective exploitation and protection of the Commercial Rights (including through the implementation of government guarantees and tabling of supplementary legislation).
- 43.3. Each Host Club and its Member Association or Host Association (as appropriate) shall appoint a reasonable number of personnel to assist the AFC General Secretariat in the implementation and enforcement of its rights protection programme.

44. CLEAN SITE

Quarter-finals

- 44.1. Except where otherwise instructed or notified by the AFC General Secretariat, the Host Club and its Member Association shall deliver the Stadium and Official Training Sites as a Clean Site two (2) days before the Match and official training at the Official Training Site, respectively, until the completion of the Match.

Preliminary Stage, Group Stage and the Finals

- 44.2. Except where otherwise instructed or notified by the AFC General Secretariat, the Host Club and its Member Association or Host Association (as appropriate) shall deliver the Stadium and Official Training Sites as a Clean Site seven (7) days before the first Match of the respective stage, until one (1) day after the last Match at each Stadium or the last training at each Official Training Site.

45. ADVERTISING AND BRANDING

- 45.1. Except where otherwise stipulated or notified by the AFC General Secretariat, each Host Club and its Member Association shall ensure that all relevant approvals are secured and unrestricted access for the placement and publishing of advertising or branding of the Competition shall be available to the AFC two (2) days before each Match at the Stadium or training at the Official Training Site.

SECTION 9 : SAFETY AND SECURITY

46. GENERAL PRINCIPLES

- 46.1. All matters relating to safety and security shall be undertaken in compliance with the AFC Stadium Regulations and AFC Safety and Security Regulations.
- 46.2. Each Host Club or Host Association (as appropriate) shall, in cooperation with the relevant government authorities and/or Stadium owners, devise, plan, and implement adequate security and safety measures for the Competition at all Controlled Access Areas within the Venue and other relevant locations to protect all relevant persons, including without limitation the AFC Delegation, Official Team Delegations, Commercial Rights Partner, Commercial Affiliates, Media, spectators, all goods brought in by the AFC, Official Team Delegations, Commercial Rights Partner, and Commercial Affiliates.
- 46.3. Each Host Club or Host Association (as appropriate) shall issue a detailed security plan in the form of a binding agreement with, without limitation, the management of the Stadium, Official Training Site(s), and the Accommodation of the AFC Delegation and Official Team Delegations. This security plan shall be based upon the principles set out in the AFC Stadium Regulations and AFC Safety and Security Regulations including, without limitation, a stadium evacuation plan, the stadium safety certificate and security personnel deployment plans.
- 46.4. The Host Club or Host Association (as appropriate) shall discharge the AFC and hold it harmless from all responsibility and relinquish any claim against the AFC and the members of its delegation for any damages resulting from any act or omission relating to the organisation of the Competition to the exclusion of damages caused by the AFC or the members of its delegation acting with intent or gross negligence.

SECTION 10 : MEDICAL AND ANTI-DOPING

47. PRE-COMPETITION MEDICAL ASSESSMENT

- 47.1. Each Participating Club and its Member Association shall ensure that each Participating Player undergoes a Pre-Competition Medical Assessment (PCMA) at least thirty (30) days prior to its first Match of the Competition.
 - 47.1.1. Participating Players that have undertaken a PCMA for a FIFA or other AFC competition may provide the AFC General Secretariat with the physician and player's declaration form originally provided to FIFA or the AFC, provided that the PCMA was conducted within one (1) year of the start of the Competition.
 - 47.1.2. The AFC General Secretariat shall provide all Participating Clubs and their Member Associations with the PCMA form setting out the necessary matters to be tested, which shall include testing to prevent players from experiencing sudden cardiac death during any Match.
 - 47.1.3. Each Participating Club and its Member Association must submit to the AFC General Secretariat, by latest ten (10) days prior to the first Match of the Competition, the following signed documents:
 - 47.1.3.1. Participating Club Declaration of Agreement to the PCMA; and
 - 47.1.3.2. for each Participating Player, the Player and Examining Physician Declaration for PCMA.
 - 47.1.4. Any player for whom the required documents are not provided is not eligible to be registered for the Competition.
- 47.2. The AFC Medical Committee may, at its sole discretion, order any further medical evaluation of a Participating Player that it deems necessary. The cost of such further testing shall be borne by the AFC.

48. FACILITIES AND PERSONNEL

- 48.1. Each Host Club or Host Association (as appropriate) shall provide a medical room and a doping control room fully equipped with all items stipulated in the Manual.
- 48.2. A Host Club or a Host Association (as appropriate) shall be fined:
 - 48.2.1. at least USD20,000 for failing to fully equip the medical room; or
 - 48.2.2. at least USD10,000 for failing to fully equip the doping control room; or
 - 48.2.3. at least USD40,000 for failing to fully equip both rooms.

- 48.2.4. The AFC Disciplinary and Ethics Committee may impose further sanctions at its discretion.
- 48.3. Each Host Club or Host Association (as appropriate) shall provide all medical personnel and doping control personnel stipulated in the Manual.
- 48.4. A Host Club or Host Association (as appropriate) shall be fined:
 - 48.4.1. at least USD10,000 for failing to provide all required doping control personnel; or
 - 48.4.2. at least USD20,000 for failing to provide all required medical personnel.
 - 48.4.3. The AFC Disciplinary and Ethics Committee may impose further sanctions at its discretion.

49. ANTI-DOPING

- 49.1. Doping is strictly prohibited. The AFC Anti-Doping Regulations, the AFC Disciplinary and Ethics Code, and all relevant AFC directives in relation to anti-doping are applicable to the Competition.
- 49.2. The AFC General Secretariat shall inform each Participating Club and its Member Association by means of a circular of the doping control procedure for the Competition.
- 49.3. The AFC Anti-Doping unit (mandated by the AFC Medical Committee to handle the organisation and administration of anti-doping activities) shall be responsible for the approval of the WADA-accredited laboratory which shall carry out the analysis of all doping samples.

50. GENDER VERIFICATION

- 50.1. Gender verification is not mandatory for Participating Players to register for the Competition, however, recognising the possibility that such matters may be challenged or otherwise may require further investigation, the AFC reserves the right to take appropriate measures to determine the eligibility of a Participating Player at its sole discretion (including by ordering medical testing and/or procedures). Participating Players and Participating Clubs shall comply with the instructions of the AFC in this regard. Cases of non-compliance may be referred to the AFC Disciplinary and Ethics Committee.
- 50.2. Strict confidentiality shall be observed in the conduct of such measures.

SECTION 11: FINANCIAL PROVISIONS

51. GENERAL RESPONSIBILITIES

- 51.1. Any financial payments to be made by the AFC in accordance with these Regulations shall be subject to all applicable laws, regulations, orders, by-laws and international sanctions.

52. LOGISTICAL ARRANGEMENTS FOR PARTICIPATING CLUBS

Quarter-finals

- 52.1. Participating Clubs shall settle all logistical costs among themselves. The following conditions shall apply during the official period of two (2) days prior to each Match until one (1) day after the Match:
- 52.1.1. the Away Club shall cover its return international and domestic travel costs to the Venue or the nearest airport, as well as board, lodging costs and incidental expenses;
 - 52.1.2. the Host Club shall cover the following domestic transport costs at the Venue for the entire Official Team Delegation of the Away Club, subject to flight connections;
 - 52.1.2.1. one (1) bus with a minimum of forty-five (45) seats;
 - 52.1.2.2. one (1) multipurpose vehicle with a minimum of seven (7) seats; and
 - 52.1.2.3. one (1) luggage truck for airport transfers, hotel transfers (if applicable) and Match day;
 - 52.1.3. the Host Club shall provide the Away Club with a liaison officer for the Away Club's entire stay at the Venue;
 - 52.1.4. subject to the relevant national laws and policies, where requested by the AFC, a police escort shall be provided by the Host Club to the Official Team Delegation of the Away Club, in order that the Official Team Delegation of the Away Club arrives promptly and punctually to its training, Matches, Official Functions, and airport transfers;
 - 52.1.5. the Participating Clubs are not permitted to stay at the same hotel as each other or at the hotel chosen for the AFC Delegation;
 - 52.1.6. details of the logistical arrangements relating to a Match (including the matters set out above) shall be notified to the AFC General Secretariat by the relevant Participating Clubs in advance of the Match; and
 - 52.1.7. any disputes arising regarding the financial provisions under this Article 52 shall be resolved amongst the relevant Participating Clubs and/or their Member Associations but may be submitted to the AFC Women's Football Committee for a final decision.

Preliminary Stage, Group Stage and Finals

- 52.2. The Participating Clubs shall cover their return international and domestic travel costs to the Venue or the nearest airport, as well as incidental expenses.
- 52.3. The Host Club or Host Association (as appropriate) shall cover the cost of all other logistical arrangements in accordance with the list of requirements published by the AFC General Secretariat. Such arrangements shall be communicated to the Participating Clubs by circular prior to the relevant stages of the Competition.

53. LOGISTICAL ARRANGEMENTS FOR AFC DELEGATION

Quarter-finals

- 53.1. From their arrival at the Venue until their departure, each Host Club or Host Association (as appropriate) must provide at its own cost, for the AFC Delegation:
 - 53.1.1. Accommodation in an international five-star hotel different from the Official Team Delegations unless approved by the AFC (or an international four-star hotel if there are no international five-star hotels at the Venue);
 - 53.1.2. three (3) meals per day (international buffet style) and one (1) additional light meal on Match day;
 - 53.1.3. minimum six (6) litres of water per person per day, as well as ice and refreshments, at the Accommodation, referee training, and the Stadium;
 - 53.1.4. daily laundry services (but no dry cleaning or pressing) of eight (8) pieces per person per day for the Match Officials (except for the referee assessor who shall be subject to Article 53.1.5);
 - 53.1.5. daily laundry services of six (6) pieces per person per day and dry cleaning of two (2) pieces per person on alternate days for the other members of the AFC Delegation;
 - 53.1.6. activated mobile telecommunication cards (e.g. SIM cards) with sufficient credit and data;
 - 53.1.7. a Club official or representative of the Host Club should be assigned to coordinate airport reception, immigration and customs, airport transfers, domestic transportation and Accommodation for all Match Officials and the members of the AFC Delegation;
 - 53.1.8. liaison officers proficient in English;
 - 53.1.9. one (1) sedan for the AFC Match commissioner;
 - 53.1.10. one (1) multipurpose vehicle with a minimum of seven (7) seats for the Match Officials; and

53.1.11. additional vehicles upon request of the AFC General Secretariat for other officials appointed by the AFC General Secretariat.

Preliminary Stage, Group Stage and Finals

53.2. The Host Club or Host Association (as appropriate) shall cover the cost of all logistical arrangements for the AFC Delegation in accordance with the list of requirements published by the AFC General Secretariat. Such arrangements shall be communicated to the Participating Clubs by circular prior to the relevant stages of the Competition.

54. FINANCIAL CONTRIBUTION

54.1. The Financial Contribution for Participating Clubs shall be made up of one (1) or more of the following payments:

54.1.1. travel subsidy;

54.1.2. performance bonus; and

54.1.3. participation fee.

54.2. Financial Contributions shall be sent directly to the Member Association of the Participating Club(s), unless otherwise directed by the Member Association or decided by the AFC General Secretariat at its discretion.

54.3. All Financial Contributions shall be withheld should a Participating Club have any outstanding payment to be made to the AFC or another Participating Club (and/or its Member Association) and/or any unfulfilled financial obligations under the relevant Articles of these Regulations until the payment is made in full.

Travel Subsidy

54.4. In the Preliminary Stage of the Competition, the Away Club(s) shall receive a travel subsidy of USD50,000.

54.5. Notwithstanding any other provisions in these Regulations, no travel subsidy shall be provided to any Host Club which is required to play in a Neutral Venue in accordance with these Regulations.

Performance Bonus

54.6. For each Match in the Group Stage, a performance bonus of USD20,000 shall be paid to the winner based on the result of the Match at the end of normal playing time.

Participation Fee

54.7. Each Participating Club in the Group Stage shall receive a participation fee of USD100,000. In addition, each Participating Club shall subsequently receive the following participation fees for their qualification to the following stages of the Competition:

54.7.1. Quarter-finals : USD80,000; and

54.7.2. Semi-finals : USD120,000

55. PRIZE MONEY

55.1. The AFC will pay the following prize monies to each Participating Club in the final Match of the Competition:

55.1.1. Champion : USD1,000,000; and

55.1.2. Runner-up : USD500,000.

For the avoidance of doubt, the above-mentioned prize monies shall be paid in addition to the other Financial Contributions.

55.2. All prize money shall be withheld should a Participating Club have any outstanding payment to be made to the AFC or another Participating Club (and/or its Member Association) and/or any unfulfilled financial obligations under the relevant Articles of these Regulations until such time as the payment is made in full.

55.3. Five per cent (5%) of the prize monies from the Champion and runner-up in accordance with Article 55.1 shall be retained and allocated to the AFC Dream Asia Foundation to fund social responsibility activities.

56. DISCIPLINARY ACTION

56.1. Where a Host Club fails to comply with any of its obligations under Articles 51 to 53 with regard to a Match, the case shall be referred to the AFC Disciplinary and Ethics Committee. In all such instances, the AFC Disciplinary and Ethics Committee shall order the relevant Participating Club to return to the AFC any Financial Contribution that has been paid to it in respect of the relevant Match (or, if not yet paid, to forfeit its right to any Financial Contribution due to it in respect of the relevant Match) and to pay compensation for any and all damages or losses suffered by, where applicable, the other Participating Club, the AFC, the AFC Commercial Rights Partner, Commercial Affiliates and the Host Association. The amount of compensation shall be determined by the AFC Disciplinary and Ethics Committee, which may impose further sanctions at its discretion.

SECTION 12 : AWARDS

57. TROPHY, AWARDS AND MEDALS

- 57.1. The original trophy of the Competition shall be presented as a formality to the Champion during the award ceremony after the final Match of the Competition. Following the conclusion of the ceremony, the original trophy shall immediately be returned to the AFC and remain in the possession of the AFC at all times. The Champion shall subsequently be awarded a replica by the AFC for its permanent possession.
- 57.2. The replica trophy awarded to the Champion must remain within its control at all times and must not leave its region or territory of its Member Association without the prior written consent of the AFC General Secretariat. The Champion must not permit the replica trophy to be used in any context where a third party (including, without limitation, their sponsors and other commercial partners) is granted visibility or in any other way which could lead to an association between any third party and the trophy and/or the Competition. The AFC General Secretariat may issue additional trophy guidelines which the Champion must comply with.
- 57.3. The following awards of the Competition shall be presented in accordance with the Manual:
 - 57.3.1. Most Valuable Player;
 - 57.3.2. Top Goal Scorer; and
 - 57.3.3. AFC Fair Play Award.
- 57.4. Goals scored in the Preliminary Stage are not taken into account for determining the Top Goal Scorer.
- 57.5. The AFC shall award the following medals:
 - 57.5.1. fifty-five (55) medals to the Champion; and
 - 57.5.2. fifty-five (55) medals to the runner-up.
- 57.6. Additional medals may be produced upon request and at the cost of the requesting Participating Club.
- 57.7. The AFC Women's Football Committee may decide to introduce additional awards.

58. AWARD CEREMONY

- 58.1. An award ceremony, managed and controlled by the AFC and coordinated with the Host Club, Host Association, and the AFC Commercial Rights Partner, shall be held immediately after the final Match of the Competition to present the trophy, awards and medals listed in Article 57.

- 58.2. The Participating Players and Participating Clubs that qualify to receive the trophy, awards and medals are required to attend the relevant award ceremony. Relevant Participating Clubs shall be represented by the twenty-three (23) Participating Players and eleven (11) Participating Officials registered in the Official Team Delegation for the final Match of the Competition. No other officials, players, or staff of the Participating Clubs may participate in the award ceremony.

SECTION 12 : DISCIPLINARY

59. DISCIPLINARY MEASURES

- 59.1. All disciplinary measures in relation to the Competition shall be undertaken in accordance with the current AFC Statutes, AFC Disciplinary and Ethics Code, and all relevant AFC regulations and circulars.
- 59.2. The AFC General Secretariat may introduce new disciplinary rules and sanctions for the duration of the Competition. Such rules shall be communicated to the Participating Clubs and their Member Associations thirty (30) days before the first Match of the Competition at the latest.
- 59.3. Only Participating Players and Participating Officials may serve Match suspensions in the Competition. For the avoidance of doubt, this requires the registration of the relevant individual within a registration period in accordance with the deadlines set out in these Regulations.
- 59.4. All Participating Players and Participating Officials agree to:
 - 59.4.1. comply with the provisions of the AFC Disciplinary and Ethics Code, in particular by respecting the spirit and principles of fair play, not engaging in violent/unsporting behaviour, respecting the authority of Match Officials, not making bets in connection with any Match and not engaging in any activities linked to the manipulation of Matches; and
 - 59.4.2. refrain from doping and doping-related activities, and comply with the provisions of the AFC Anti-Doping Regulations.

60. GOOD CONDUCT

- 60.1. Participating Clubs are liable for the improper conduct of:
 - 60.1.1. any member of its Official Team Delegation; and/or
 - 60.1.2. any person affiliated with it and/or carrying out duties on their behalf throughout the Competition.
- 60.2. For any violation of Article 60.1, the AFC Disciplinary and Ethics Committee may issue any sanction listed in the AFC Disciplinary and Ethics Code.

61. ADMINISTRATIVE PROCEDURE

- 61.1. Subject to the AFC Disciplinary and Ethics Code, for any offence set out in these Regulations with a listed minimum fine, where it is the first such offence committed by a party:

- 61.1.1. the AFC, after completing its investigation but prior to opening disciplinary proceedings, may write to the party and make an offer to compound the offence and reduce the listed fine by twenty per cent (20%) should the party admit to the offence;
- 61.1.2. if the offence is admitted, the AFC shall submit the compounded offence to the Chairperson of the AFC Disciplinary and Ethics Committee for approval;
 - 61.1.2.1. should the party deny the offence, the AFC shall open disciplinary proceedings;
- 61.1.3. upon approval of the Chairperson of the AFC Disciplinary and Ethics Committee, the sanction shall be notified and applied administratively by the AFC;
 - 61.1.3.1. should the Chairperson of the AFC Disciplinary and Ethics Committee not approve the compounded offence, the AFC shall open disciplinary proceedings;
- 61.1.4. by agreeing to compound the offence, the party waives its right to request a motivated decision or appeal the sanction issued; and
- 61.1.5. any sanction issued administratively comes into force immediately upon notification in accordance with the AFC Disciplinary and Ethics Code.

62. CAUTIONS AND EXPULSIONS

- 62.1. All matters relating to cautions and/or expulsions, including the carrying forward of cautions between stages of the Competition, shall be undertaken in accordance with the AFC Disciplinary and Ethics Code, except where expressly set out below.
 - 62.1.1. Subject to Articles 62.1.2 to 62.1.3, if a Participating Player or Participating Official receives a caution in three (3) separate Matches in the Competition, the relevant individual is automatically suspended from the next Match in the Competition.
 - 62.1.2. Any Participating Player or Participating Official who completes the Preliminary Stage having only received one (1) or two (2) caution(s) in separate matches shall not carry over the caution to the next stage of the Competition.
 - 62.1.3. Any Participating Player or Participating Official who completes the Group Stage having received one (1) or two (2) caution(s) in separate matches shall not carry over the caution(s) to the quarter-finals.

63. PROTEST

- 63.1. For the purpose of these Regulations, a protest is an objection of any kind related to any event and/or matter that has a direct effect on a Match.

- 63.2. Unless otherwise stipulated in these Regulations, to be considered valid, a protest must be:
- 63.2.1. submitted in writing (using the appropriate Protest Form issued by the AFC General Secretariat) to the AFC Match commissioner for the relevant Match within two (2) hours of the final whistle or, if the relevant Match was cancelled or abandoned, within two (2) hours of the decision to cancel or abandon the Match (the "Protest Deadline");
 - 63.2.2. followed up with a full written report (including a copy of the original Protest Form) which must be sent to the AFC General Secretariat within twenty-four (24) hours of the Protest Deadline; and
 - 63.2.3. accompanied by a non-refundable fee of USD1,000 (non-inclusive of any bank charges) which must be transmitted to the bank account nominated by the AFC General Secretariat within twenty-four (24) hours of the Protest Deadline.
- 63.3. No protest shall be lodged relating to the referee's decisions regarding facts connected with play. Such decisions are final and binding and not subject to appeal, unless otherwise stipulated in the AFC Disciplinary and Ethics Code. The same applies to any potential issue concerning the use and/or operation of any goal-line technology (GLT), video assistant referee (VAR) system, and/or any other football technologies.
- 63.4. If any of the formal requirements set out in Article 63.2 are not met, the relevant protest shall be disregarded. The AFC General Secretariat decides whether such formal requirements have been met. Such decisions are final and binding and not appealable.
- 63.5. Subject to Article 63.4 and any other exceptions set out in these Regulations, the AFC Disciplinary and Ethics Code, the AFC Statutes and/or any other applicable AFC regulations, the AFC Disciplinary and Ethics Committee shall make decisions on protests. Should the AFC Disciplinary and Ethics Committee determine that a protest is unfounded or irresponsible, it may impose a fine. The AFC Disciplinary and Ethics Committee may transfer a protest to the AFC Women's Football Committee for its decision if it is deemed to be purely operational in nature.

64. ARBITRATION

- 64.1. Any dispute in connection with the Competition shall be promptly settled by negotiation.
- 64.2. In compliance with the AFC Statutes, Participating Clubs, Member Associations, Participating Players and Participating Officials are prohibited from initiating disputes in an ordinary court of law and must submit to the exclusive jurisdiction of the AFC.
- 64.3. Participating Clubs, Member Associations, Participating Players, and Participating Officials acknowledge and accept that, once all internal channels have been exhausted at the AFC, their sole recourse shall be the Court of Arbitration for Sport (CAS). The Code of Sports-related Arbitration shall be applicable. The language of arbitration shall be English. Any hearing, if required, shall (if conducted in person) take place at the CAS Alternative Hearing Centre in Kuala Lumpur, Malaysia or (if online) be carried out during business hours in Kuala Lumpur, Malaysia.

SECTION 13: CLOSING PROVISIONS

64. FINALS

- 65.1. The Finals shall be organised and managed by the AFC General Secretariat in collaboration with the AFC Commercial Rights Partner, the Host Club and/or Host Association, including, without limitation:
 - 65.1.1. Tickets and Ticketing in accordance with Articles 39.4 and 41.6;
 - 65.1.2. protocol;
 - 65.1.3. Match organisation;
 - 65.1.4. commercial operations; and
 - 65.1.5. media operations.
- 65.2. Any additional events planned before, during and after the Finals by a Participating Club shall be communicated at least seven (7) days prior to the Finals and be approved by the AFC General Secretariat.

66. SPECIAL INSTRUCTIONS

- 66.1. The AFC General Secretariat and/or AFC Women's Football Committee (as appropriate) shall, in conjunction with the Host Associations, issue any instructions necessitated by special circumstances which might arise in the organisation of Matches.
- 66.2. These instructions shall form an integral part of these Regulations.

67. DECISIONS

- 67.1. All decisions made in accordance with these Regulations, except where expressly identified otherwise, are final and binding and not appealable in accordance with the AFC Statutes.

68. AMENDMENTS

- 68.1. The AFC reserves the right to make amendments to any part of these Regulations for any reason whatsoever. Such amendments shall be duly communicated in due course.

69. FORCE MAJEURE

- 69.1. The AFC Women's Football Committee is the only body capable of declaring a Force Majeure event.

70. MATTERS NOT PROVIDED FOR

- 70.1. Matters not provided for in these Regulations shall be decided by the AFC Women's Football Committee. Such decisions are final and binding and not appealable.

71. IMPLEMENTING PROVISIONS

- 71.1. The AFC General Secretariat is entrusted with the operational management of the Competition and is therefore entitled to make decisions and adopt the detailed provisions necessary for implementing these Regulations.

72. ENFORCEMENT

- 72.1. These Regulations were ratified by the AFC Executive Committee on 9 April 2026 and came into force immediately.

APPENDIX 1 : AFC WOMEN'S CLUB COMPETITIONS RANKING PRINCIPLES

HOW ARE THE RANKINGS DETERMINED?

The AFC Women's Club Competitions Ranking is a ranking of Member Associations based on the results of all their clubs in the AFC Women's Champions League ("AWCL") and the latest FIFA Women's World Ranking (wherever applicable).

Ranking of the AWCL shall be determined as follows:

- 2024/25 to 2027/28 Ranking = 70% club points + 30% national team points
- 2028/29 and 2029/30 Ranking = 90% club points + 10% national team points
- 2030/31 onwards Ranking = 100% club points

To ensure the rankings better reflect the latest sporting results, the ranking shall progressively accumulate the club points from the previous seasons until eight (8) seasons have been accumulated. In this respect, the club points obtained in each relevant season shall have a different weighted value as below:

The points of the Member Association ranked 1st in the club points shall be converted to full points (e.g., 70 points if 70%). The points of the remaining Member Associations shall be adjusted proportionally less compared to the points of the 1st ranked Member Association for the same season.

The points of the Member Association ranked 1st in the national team points shall be converted to full points (e.g., 30 points if 30%). The points of the remaining Member Associations shall be adjusted proportionally less compared to the points of the 1st ranked Member Association for the same season.

The rankings determine the slot allocation of each Member Association in the forthcoming AFC Women's Champions League.

HOW ARE THE CLUB POINTS OF EACH SEASON CALCULATED?

Each participating club is awarded points as follows:

Preliminary Stage

- Participation bonus points shall only be awarded to Participating Clubs entering and eliminated from the AWCL Preliminary Stage. For the avoidance of doubt, no bonus points shall be awarded to Participating Clubs entering the AWCL Preliminary Stage and subsequently qualifying for the AWCL Group Stage, as they will receive separate points for participating in the AWCL Group Stage.

Group Stage & Knockout Stage

- In consideration of any discrepancy in the format and/or number of matches played between the Participating Clubs of the AWCL in the same season, each Participating Club's points from the Group Stage & Knockout Stage shall be calculated as below:

Club A's points from the Group Stage & Knockout Stage = Sum of points awarded in the AWCL × (maximum points obtainable in the AWCL ÷ maximum points obtainable from relevant format and/or number of matches)

e.g. calculation of club points in Group Stage & Knockout Stage of Club A

Max. Points obtainable from Group Stage & Knockout Stage = 27

Max. Points obtainable for Club A from Group Stage & Knockout Stage = 24

Points awarded to Club A from Group Stage & Knockout Stage = 18

Club A's Points from Group Stage & Knockout Stage = $18 \times (27 \div 24) = 20.250$

Each Participating Club's total points for each season shall be calculated as below:

- *Participating Club's points = Sum of points from Preliminary Stage + sum of points from Group Stage & Knockout Stage*

Each Member Association's club points for each season shall be calculated as below:

- *Member Association's club points for a season = Sum of points of Member Association's Participating Clubs in Preliminary Stage + average points of Member Association's Participating Clubs in Group Stage & Knockout Stage*

In the event that any Participating Club withdraws from the Competition after it has commenced, all of its Matches shall be cancelled and considered null and void, and the relevant Participating Club shall receive zero (0) Participating Club's points.

In cases of Force Majeure, as determined by the AFC Women's Football Committee, the relevant Participating Club shall be excluded from the calculation of the Member Association's club points for the Sporting Season.

HOW ARE THE NATIONAL TEAM POINTS OF EACH SEASON CALCULATED?

The latest FIFA Women's World Ranking total points at the time of the publication of the ranking shall determine the Member Associations' national team points.

ADDITIONAL NOTES

Performance points (points for wins and draws) are determined based on the results at the end of normal playing time. Results of Extra Time and Penalties (Penalty Shoot-outs) shall not be taken into consideration.

Points shall be rounded up or down, as appropriate, to the third decimal point (e.g., 1.1234 becomes 1.123 and 1.1235 becomes 1.124) when calculating the total points of each Member Association.

In case of a tie in the total points of two (2) or more Member Associations, the following shall apply to determine the higher-ranked Member Association, in descending order:

- 1) ranking points of the most recent season in which the points are not equal among the Member Associations in question;

- 2) club points of the most recent season in which the club points are not equal among the Member Associations in question; and
- 3) the latest FIFA Women's World Ranking of the Member Associations in question at the time of the publication of the ranking.
